<u>13:30-15:00</u> Session II: Productive capacities and structural economic transformation: measuring and benchmarking performances by using UNCTAD's Productive Capacities Index (PCI) for evidence-based policy formulation and implementation in Malawi: Gaps and limitations and the way forward

This session is intended to relate the concepts of productive capacities and structural economic transformation to Malawi's development endeavours, including implications for graduation from the LDC category. The session will discuss UNCTAD's Productive Capacities Index (PCI), which is an innovative approach applied by UNCTAD to measure and benchmark the level of development of productive capacities, and the National Productive Capacities Gap

Assessment as the prelude for building productive capacities. It will discuss the success stories concerned with building productive capacities and accelerating structural economic transformation and examine the level of productive capacities of Malawi with implications to national, regional policies as well as international support measures.

The process of building productive capacities requires improvements in infrastructure to galvanize countries' economic interaction and its growth. At the same time, Malawi's scores in the Productive Capacities Index' components on transport, energy and ICT are very low compared to its peers recruited from other African LDCs. This session will discuss the critical aspects of this infrastructure, namely, access to and development of energy resources and electricity, to ICT infrastructure and transport network.

It will point to the manufacturing sector as desired focus of structural transformation.
