Introduction

The Technology Assessment (TA) Project in Zambia on biogas is approaching its conclusion. The Zambian team has successfully navigated through all the steps outlined in the United Nations Conference on Trade and Development (UNCTAD) TA Methodology, resulting in the completion of a comprehensive TA Report. This report, which analyses the role of biogas within the country's national development, as well as its challenges and opportunities, is accompanied by an Action Plan aimed at facilitating the widespread adoption and diffusion of biogas technology.

A crucial step in finalizing this endeavour is to validate the findings and recommendations of the TA Report, along with the proposed Action Plan. Recognising the significance of stakeholder input in this validation process, the Ministry of Technology and Science, in collaboration with UNCTAD, is organizing a joint national validation workshop. This workshop is designed to provide stakeholders with a platform to offer feedback on the project outputs before they undergo final endorsement by the TA Steering Committee.

Following the endorsement, Honourable Minister Felix C. Mutati will launch the TA Report and Action Plan. The validation workshop is set to be held in Lusaka from 13 to 16 February 2024, while the launch event will take place at a biogas site in the afternoon of 16 February.
