The standard of quality requirements for dried melons produced in Uzbekistan was approved at the UN meeting

- . At the meeting of the UN Economic Commission for Europe on November 20, 2019, an international standard developed by Uzbekistan was adopted for the first time.
- This standard, which defines the quality requirements for dried melon products, was developed with the support of Uzstandard Agency, «O'zbekoziqovqatxolding», experts from local companies and international organizations.
- The standard, tested in practice, was positively evaluated by the UN Economic Commission for Europe, supported in the international arena, including the United States, Germany, Turkey, Iran, Central Asian countries.

Importance of Global G.A.P standard

- Introduction of Global G.A.P. standard in enterprises producing agricultural products will pave the way for the export of products to European markets.**
- This standard has been introduced and certified by the Uzstandard Agency in cooperation with the Ministry of Investment and Foreign Trade at more than 60 enterprises in the regions.**
- Voluntary certificates such as the Global G.A.P. such as technical compliance with the EU legislative requirements for the hygiene of agricultural products, and often EU importers require this certificate from the third countries.**

Certification results

- As a result of certification, the main activity of the production cooperative «DEKHCANOBOD ASL ANORI», located in the Mirzabad district of the Syr-Darya region, is the production of natural pomegranate juice. Previously, the company's products were exported for \$2, while France and Estonia have a buyer for \$4 per litre.
- As an alternative to the international Global G.A.P. countries such as Germany, France, Estonia, Japan, China have expressed interest in the products produced by this standard.

ISO 22000: Voluntary but one of the most important certifications for entering to the EU market

ISO 22000: 2005 sets requirements for a food safety management system, according to which an organization in the food chain should be able to manage food safety to ensure safety in human consumption.

This applies to all organizations, regardless of size, which are involved in any direction of the food chain and want to implement systems that continuously provide safe products. Tools that meet the requirements of ISO 22000: 2005 can be implemented using internal and / or external resources

Certification works on the basis of ISO 22000 standard

The Uzstandard Agency provided practical assistance in the certification of 266 local enterprises on the basis of the ISO 22 000 standard. As an example, IRON LIT LLC exported more than 1,000 tons of products to foreign countries as a result of this certificate.
