## First Meeting of the Working Group on improvements to the Internet Governance Forum (IGF)

Montreux. Switzerland

25 February and 26 February 2011

## Chairman's summary of the meeting

- 1. The first meeting of the Working Group on improvements to the Internet Governance Forum (IGF) was held in the Grand Hotel Majestic in Montreux, Switzerland on 25 and 26 February 2011. The meeting was chaired by Mr. Frédéric Riehl (Switzerland).
- 2. Following the opening statement by the Chair, the Working Group discussed a number of procedural issues related to the meeting agenda and working methods. Several delegations underlined the importance of equal representation from developed and developing countries in the Working Group. Avenues to provide funding for developing country representatives should be further explored and made easily accessible. The Working Group agreed to hold its next meeting on 24 and 25 March 2011 in Geneva in the premises of the Palais des Nations or its proximity.
- 3. The Working Group held a detailed discussion on the meeting agenda. Some delegations expressed reservations regarding the provisional draft agenda. They deemed the draft agenda to be too closely modeled on a draft structure that the Chair had sent out to all members and invited participants to provide comments on the themes proposed in the draft structure. These delegations considered that the draft structure could still be improved and that the current agenda should therefore also be revised. Other delegations believed that, rather than deciding on a structure from the start, a discussion of the different themes proposed in the agenda would help identify important issues better and make it easier to shape a structure for the Group's report.
- 4. Some delegations also pointed out that the structure of the Group's report should have a strong logical hierarchy, starting with the overall objective of improvements to the IGF with reference in particular to the Tunis Agenda<sup>1</sup> and General Assembly Resolution (A/65/141) on "Information and communications technologies for development", adopted on 20 December 2010. The report should then explore the structures and mechanisms that would be needed to achieving this aim before going into the measures that are necessary to sustain these structures and mechanisms.

- 5. Other delegations regarded it important that the report also looks at past achievements of the IGF while others proposed to add a separate point on the Multistakeholder Advisory Group (MAG) in the report's structure.
- 6. The Working Group finally agreed that it would decide on a final structure for the report at the Group's next meeting. The delegations also agreed that, rather than adhering to the provisional draft agenda, they would continue the meeting by exploring the following list of issues:
  - 1) Review of IGF vis-à-vis Tunis Agenda paragraphs 72 to 80
  - 2) Improving the IGF with a view to linking it to the broader dialogue on global Internet governance as directed by UNGA resolution
  - 3) How to enhance the contribution of IGF to socio-economic development and towards IADGs including enhancing participation of developing countries
  - 4) Shaping the outcome of IGF meetings
  - 5) Outreach to and cooperation with other organisations and fora dealing with IG issues
  - 6) Inclusiveness of the IGF process and of participation at the IGF meetings (in particular with regard to stakeholders from developing countries)
  - 7) Working methods of the IGF, in particular improving the preparation process modalities
  - 7.1) Current modalities: open consultation and MAG
  - 7.2) IGF Secretariat
  - 8) Format of the IGF meetings
  - 9) Financing the Forum (exploring further options for financing)
  - 9.1) Review of the current situation
  - 9.2) Options for ensuring predictability, transparency and accountability in financing IGF
  - 10) Conclusions and Recommendations
  - 11) Provisional agenda of the second meeting of the Working Group

The Working Group paid particular attention to the issue of outreach to and cooperation with other organizations and forums dealing with internet governance issues and the outcome of IGF meetings. One delegation suggested that the IGF should improve its links with the WSIS (World Summit on the Information Society) follow-up process. Several delegations also evoked new ways of shaping the IGF's outcome. One delegation spoke of a need to consolidate views expressed at the IGF and to translate them into clear policy actions and opinions to be fed into other IG- related policy forums. Another delegation suggested that the MAG create working groups, which would work on specific Internet policy issues that would then be discussed in the IGF. The MAG working group would compile points of convergence reached on these issues or lists of alternative policy proposals and submit them to the UN Commission on Science and Technology for Development (CSTD) for consideration. Another delegation warned that the IGF should avoid binding commitments because the outcomes at IGF discussions would always be subjective and could not be considered definite.

- 8. Several delegations stressed the importance of reaching out and including all relevant stakeholders in the IGF process. In particular, representatives of the business community and civil society as well as government officials from developing countries should be more represented and better involved in the IGF. One delegation underlined that improving support for participation was a collective responsibility. It was also suggested that high quality documentation on the outcomes of IGF discussions as well as on lessons learned could make the meeting more attractive for governments. One delegation pointed out that in order to become more interesting and relevant to developing countries, the IGF should have an impact on Internationally Agreed Development Goals (IADGs).
- 9. The Working Group also paid particular attention to the work of the MAG. Some delegations considered that the MAG needed to be more inclusive and transparent. Other delegations stressed that the MAG had already become increasingly open and transparent, for example, by allowing observers to participate in its meetings or by making meeting transcripts available publicly. Several delegations agreed that the MAG should become more representative and inclusive, for example by reviewing the selection process or by building the capacity of new members so that they can participate actively in meetings.
- 10. On the issue of the financing of the Forum, the IGF Secretariat answered a number of questions regarding current IGF funding arrangements. The Group then addressed possible further financing options and some delegations proposed the introduction of a regular budget financed by the United Nations. Other delegations expressed their support of the current funding arrangements, where the IGF is financed through voluntary contributions.
- 11. The Working Group agreed that a questionnaire, based on points 1 to 9 of the above list of issues, will be published after the first meeting with an invitation to all relevant stakeholders to submit their comments by 14 March 2011. The individual contributions received as well as a compilation of the contributions will then be transmitted to all members and invited participants of the Working Group on time for the second meeting. The Group will then draft its final report based on those contributions.
