This session is intended to relate the concepts of productive capacities and structural economic transformation to Mozambique's development endeavors, including policy implications for inclusive growth and sustainable development. The session will discuss UNCTAD's Productive Capacities Index (PCI), which is an innovative approach applied by UNCTAD to measure and

benchmark the level of development of productive capacities, and the National Productive Capacities Gap Assessment as the prelude for building productive capacities. It will discuss the success stories concerned with building productive capacities and accelerating structural economic transformation and examine the level of productive capacities of Mozambique with implications to national, regional policies as well as international support measures.
