





Hybrid National Workshop on Coherent Strategies for Developing Productive Capacities in Tanzania

Date: 29-30 April 2021

Time: 12:00-15:00 EAT (Tanzania Time)

Concept Note and Programme

Context and objective

The Government of Tanzania has a strong commitment to developing domestic productive capacities and transforming the structure of its economy from low to higher productivity activities within and across sectors. While some progress has been made over the past few decades, manufacturing continues to play a relatively small role in the economy both in terms of its share of output and contribution to exports. Some of the factors that have been identified as accounting for the low development of domestic productive capacities include volatile or insufficient domestic demand, shortage of inputs and spare parts, unreliable and costly power supply, shortage of skilled labour, inadequate access to financial services, high cost of credit and challenges in policy formulation and implementation. The Government understands these challenges and has intensified efforts to address them through various initiatives geared towards boosting manufacturing output and exports, promoting agricultural production, and strengthening intersectoral linkages. It is also in the process of reviewing its trade and industrial strategies with a view to better harnessing the potential of trade for transformation and development.

Against this backdrop, this workshop seeks to provide a platform for policymakers and other relevant stakeholders to discuss the opportunities and challenges to developing productive capacities in Tanzania. It also seeks to identify holistic and coherent strategies to build new productive capacities as well as better utilize existing capacities to enhance prospects of achieving Vision 2025 and the Sustainable Development Goals (SDGs).

Expected outcomes

- Enhanced capacities of the trade, industry and planning ministries to develop countryspecific strategies for productive capacity development and structural economic transformation.
- 2. Enhanced capacities of government officials and practitioners to implement coherent productive capacities policies, with a view to improving their international competitiveness and integration into the world economy.

Organization and format

The event will be organized by the Tanzania Ministry of Industry and Trade, the United Nations Conference on Trade and Development (UNCTAD), and the United Nations Resident Coordinator's Office in Tanzania. The meeting will be in the form of two half-day hybrid workshops tentatively scheduled to take place on the 29th and 30th of April 2021 at 12:00-15:00 EAT (Tanzania Time), that is 11:00-14:00 CET.

Target audience

The workshop is for policymakers in the Ministries of Industry and Trade, Economic Development or Planning, Finance, Infrastructure, and Agriculture. Other target local stakeholders include: Private Sector firms, Central Bank, Chambers of Commerce, Universities and Research Institutions, National Statistical Bureaus, Association of Female Entrepreneurs, and partners.
