Competition Law, Policy and Regulation in the Digital Era

Digital platforms are essential elements of today's economy. This has become even more evident since the outbreak of the COVID-19 pandemic. The increasing use of online services allowed digital platforms to grow larger and more powerful out of the pandemic. Competition in digital markets has become a key issue at stake for Governments and competition authorities around the world. At UNCTAD, this issue has been researched and discussed in previous meetings.

Competition authorities around the world have been facing common challenges in law enforcement in digital markets. To address these challenges, competition authorities have taken initiatives varying from adopting new regulation to amending competition law. These recent developments show the proactive efforts made by competition authorities and Governments to restore competition and maintain markets open and accessible to rivals in the digital economy.

This session will explore recent competition cases, initiatives and developments in the digital economy, and discuss how to complement competition law and regulation to achieve fair competition in digital markets and ensure that these markets are fair, open and accessible to new entrants. The session will further address the interaction between competition law and policy and consumer protection and data protection.

- (a) Does competition law and policy need to be complemented by regulation to restore fair competition in digital markets?
- (b) How can regulation contribute to achieving open and accessible digital markets?
- (c) How should competition authorities interact with Governments and other regulatory authorities in regulating digital markets?
