Consumer Law, Policy and Regulatory Actions in Response to and in the Aftermath of the COVID-19 Pandemic

UNCTAD secretariat note¹ addresses the impact of the pandemic on the global economy and, in particular on consumers and provides an overview of member State's responses during the pandemic. Consumer protection authorities have taken actions in response to the challenges arising from the unprecedented crisis in a timely, appropriate, and effective manner, drawing on the United Nations guidelines for consumer protection. The actions undertaken by consumer protection authorities include law enforcement, regulations, cooperation with businesses, protecting vulnerable and disadvantaged consumers, and facilitating access to justice. However, consumer protection authorities continue to face challenges exacerbated by the pandemic. The secretariat note identifies two key areas of concern requiring special attention during and in the aftermath of pandemic, namely, consumer protection in digital markets with a special focus on vulnerable and disadvantaged consumers; and international cooperation in law enforcement.

In this session, panel discussions will focus on:

- (a) What will be the emerging trends and challenges in consumer protection in the aftermath of the pandemic;
- (b) What areas of the United Nations guidelines for consumer protection will need further implementation in the aftermath of the pandemic; and
- (c) How UNCTAD can better support member States, in particular developing countries, in these critical areas, and further encourage international enforcement cooperation.
