# Project on Resilient, Green and Transformative Development

in Asian Belt and Road Countries

#### **Background and Context**

Since 2022, UN Trade and Development (UNCTAD) has led a project on *Integrated Policy Strategies and Regional Policy Coordination for Resilient, Green and Transformative Development: Supporting Selected Asian BRI Partner Countries to Achieve 2030 Sustainable Development Agenda*, funded by by the 2030 Agenda for Sustainable Development Sub-Fund of the UN Peace and Development Trust Fund. The project aimed to support four major developing countries in Asia – Türkiye, Kazakhstan, Malaysia and Pakistan - in their efforts to meet the Sustainable Development Goals (SDGs) related to green transformation. Specifically, the project was designed to assist these countries in achieving the 2030 Agenda through: 1) developing effective integrated policy strategies to address key challanges related to green industrial development; 2) improving capacity at the national level to design appropriate policies, including through South-South peer-learning; and 3) strengthening economic cooperation and policy coordination at the regional level.

A first regional meeting held in Changzou, China, from 12 to 14 December 2023 brought together experts and representatives of local partners from the four project countries, local and national experts and government officials from China as well as international researchers. This meeting on *Policy Experience Sharing for Green Development Among Asian BRI Partners*, co-hosted by UNCTAD and the Chinese Academy of International Trade and Economic Cooperation (CAITEC), discussed the challenges and binding constraints faced by developing countries in formulating national strategies to achieve both climate and wider economic development goals, as well as specific issues relating to energy and industrial transitioning, green agricultural development and macroeconomic and financing frameworks required to promote green national transformation processes. Policy experience on these topics in China was shared at the meeting and through a core project publication on "China's policy strategies for green low-carbon development: Perspective from South-South cooperation, launched in November 2023 on the occasion of the Hongqiao International Economic Forum.

Between 2022 and 2025, eight national consultations took place in the four project countries, the first round of which focused on debates and analysis of binding national constraints on green industrialisation policies in each country, whereas the second round of national consultations centred on policy recommendations to develop and promote integrated national policy strategies for green industrial development. work, carried out in close cooperation with local partner institutions, resulted in well over 20 research and policy papers, available on the <u>project website</u>.

#### Purpose and key objectives

This second regional meeting, to be held in Shanghai, China, on 9 and 10 July 2025 and co-hosted by UNCTAD and CAITEC, has three main objectives:

- 1. For experts and local partners from the four project countries, to share experiences with evolving green transformation policy agendas and integrated policy strategies in their countries
- 2. For invited experts and officials from other interested countries in the region to provide insights from their national experiences with green development and relevant policy debates and issues
- 3. The launch of an Asia Green Development Partnership Network (AGDPN) by UNCTAD, together with prospective members. The purpose of the AGDPN is to disseminate policy research products, encourage policy experiences sharing, bridge and incubate concrete cooperation in the policy areas of green development and economic diversification in the Asian region. As a multi-stakeholder partnership network, the AGDPN will be an informal and non-governmental mechanism and will be self-governed by its members through a virtual platform managed by UNCTAD. UNCTAD will introduce the platform and the Terms of Reference (ToRs) of the AGDPN during this regional meeting.

The meeting will be conducted in English and Chinese with simultaneous interpretation.
