1. To what extent, in your experience,	has the "people-centred, inclusive and development-

The people-centered, inclusive and development-oriented Information Society as envisaged in the opening paragraph of the declaration of Principles has made great strides in my country but still has a long way to go. Internationally, I think we are moving towards that goal due to many similarity of the principles, with many other organisations and individuals.

The implementation of the WSIS outcomes so far has been achieved to like 45% in my country and 60%

The Implementation of WSIS Outcomes has contributed greatly towards the development of a "people-centred, inclusive and development-oriented information society" especially in the area of ICT Infrastructure and access, Content, applications and capacity-building; Governance and wider public policy aspects of the Information. Has greatly improved but in my country Nigeria still have a long way to go.

The challenges to the implementation of WSIS outcomes include the lack of adequate awareness campaign to various stakeholders in the sector, also the absence of effective Measurement and monitoring of the Information Society and proper government efforts to implement positive policy to foster growth.

The challenges so far has been addressed to a great progress, the approaches that has proved to be the most effective is the multi-stakeholder ship projects, that is collaboration between private and public sectors working in collaboration with.

The most important emerging trends include Cyber security, Online Infrastructure and access, Content, applications and capacity-building; Technical, financial and related issues to mention but a few.
