11:30–13:00 Session II: BioTrade Principles and Criteria in the post-Aichi and SDG Context

In 2018, UNCTAD and partners including UEBT and Peruvian counterparts initiated a revision process of the BioTrade Principles and Criteria (P&C) to reflect lessons learned from the experience of BioTrade practitioners or partners and align them with developments in international policy frameworks such as the Aichi Targets and SDGs, as well as the Nagoya Protocol. This session will review progress undertaken by UNCTAD and UEBT to date. The session will conclude with a presentation of the new tool being developed by UNCTAD/ITC to enable companies to carry out self-assessments in the implementation of the new BioTrade P&C.

The available financial instruments are limited and not always adapted to the production cycles and needs of BioTrade and biodiversity-based businesses. This will include the experience of CAF in green financing and the proposed Biodiversity Pioneer Fund currently being developed by WWF and Triple Jump

The CBD Secretariat has initiated a comprehensive and participatory process for the preparation of the post-2020 global biodiversity framework. This process aims at defining specific biodiversity targets supported by objective monitoring indicators and will serve as global policy orientation for the next 10 years. The process involves a series of international and regional consultations with a wide range of stakeholders, including Member States, IGOs and non-state actors. UNCTAD has been approached by several of its BioTrade partners to act as a neutral forum for facilitating engagement among SSC Members and coordinate a joint contribution to the definition of the post 2020 framework.
