#### **Opening remarks**



**Ms. Isabelle Durant**, Deputy Secretary-General, United Nations Conference on Trade and Development (UNCTAD)

Isabelle Durant, of Belgium, took up the position of Deputy Secretary-General on 3 July 2017. She served as Acting Secretary-General from 16 February to 12 September 2021. Since she joined UNCTAD, Ms. Durant has relentlessly contributed to making international trade more inclusive and greener. She has also been an advocate for gender equality. Ms. Durant has been heavily involved in the socio-economic response of the UN to the coronavirus crisis, by leading the work of UNCTAD which covered a broad range of interrelated issues including finance, technology, investment and sustainable development.

A former vice prime minister and senator of Belgium as well as vice president of the European parliament, Ms. Durant possesses solid experience in public affairs, intergovernmental processes and providing concrete assistance to countries. Ms. Durant also served as minister of transport and energy in Belgium for four years and chaired alongside the government of the time, the presidency of the European Union (EU) and particularly the presidency of the EU Council of Transport Ministers. As vice president of the European Parliament for the period 2009 to 2014, Ms. Durant chaired different permanent delegations, such as that of EU-African, Caribbean and Pacific countries following the Cotonou Agreement and other economic partnership agreements. Born in Belgium in 1954, she holds a master's degree in economic and social policy from the country's Universite Catholigue de Louvain.





**Mr. Martin Peter**, Deputy Head of Trade Promotion, State Secretariat for Economic Affairs SECO, Switzerland

Martin Peter is the Deputy Head of Trade Promotion at the Swiss State Secretariat for Economic Affairs SECO. Previously, he held various positions in SECO's development cooperation and bilateral economic relations divisions. Between 2014 and 2019, he was the Director of Swiss Economic Development Cooperation at the Swiss Embassy in Peru. Before joining SECO, Mr. Peter worked on issues related to international trade, labor conditions, vocational training, as well as social conflicts in the private, public as well as in the NGO sectors in Switzerland, Nepal and Peru. He holds a MAS in International Cooperation and Development of the Swiss Federal Institute of Technology in Zurich and a MA in International Relations of the Graduate Institute of International and Development Studies in Geneva, Switzerland.

**Ms. Mohalgo Flora Mokgohloa**, Deputy Director General, Biodiversity and Conservation, Department of Forestry, Fisheries and the Environment, South Africa

She has over 25 years environmental management experience in the public service from national, provincial to local government where she held various senior management positions. Since 1 December 2021, she assumed position of Deputy Director General for Biodiversity and Conservation in the Department of Forestry, Fisheries and Environment (DFFE) after having served in the same department as the National Project Manager for the Biodiversity Finance Initiative (BIOFIN). He led the UN Secretary General's Task Force on Digital Financing of the SDGs, was Finance Advisor in the Executive Office of the UN Secretary General, and led the G20 green finance secretariat under the Chinese, German and Argentinian Presidencies. He was on the International Advisory Board of Generation Investment Management, had advisory roles at the World Economic Forum, was CEO of AccountAbility, Visiting Professor at the Singapore Management University, and senior fellow at Tsinghua School of Economics and Management and Harvard's Kennedy School of Government. He has advised corporations, governments and multi stakeholder initiatives, and published extensively, including the awardwinning book, The Civil Corporation.

**Mr. Peter Schmidt**, Senior Adviser in Sustainable Agriculture and Value Chains, Helvetas Swiss Intercooperation

Peter Schmidt is an agronomist with over 30 years of experience in development cooperation including long term field positions in India, Kyrgyzstan and most recently Myanmar, where he served as Helvetas Country Director 2017 – mid 2021. **H.E. Mr. Colin Murdoch**, Ambassador and Permanent Observer, Permanent Delegation of the Organisation of Eastern Caribbean States to the United Nations Office in Geneva

Prior to his appointment to Geneva, Mr. Murdoch, who is a citizen of Antigua and Barbuda, had been serving as a Senior Advisor in the Office of the Prime Minister of Antigua and Barbuda since 2016. He was Permanent Secretary, Ministry of Foreign Affairs, International Trade and Immigration from 2014 to 2016, a post he also held from 1995 to 2009. He was Permanent Secretary, Ministry of Trade, Industry and Commerce from 2009 to 2014.

She is the founder of Circular Innovation Lab, a Danish think-tank based out of Copenhagen, that works with National governments, UN agencies, and International Organisations to create solutions that drive the circular economy transition. In 2020, as part of the organization's mission to foster innovation, she launched ShopC, a marketplace for circular products in the fashion and lifestyle segment. Previously she has advised and worked on projects on circular economy, public policy in both the private and public sector in organizations such as KPMG, Ellen MacArthur Foundation, and the Indian Government across several geographies in Europe and Asia.



**Ms. Marta Gomez San Juan**, Lead Expert on Bioeconomy, Food and Agriculture Organization of the United Nations

Ms. Marta Gomez San Juan is an agricultural and biosystems engineer in FAO's Office of Climate, Biodiversity and Environment. She currently ads as strategic advisor to FAO's new 10-year programme on Bioeconomy for sustainable food and agriculture. Marta works with policy-makers to develop national and regional bioeconomy strategies and develops knowledge products on sustainable and circular bioeconomy practices and policies. Since 2016, she has been coordinating the 'International Sustainable Bioeconomy Working Group', a knowledge-exchange platform focused on sustainable transformation of agri-food systems, including through emerging biological innovations and technologies. The Working Group and the FAO project were created after 62 Ministers of Agriculture at the Global Forum for Food and Agriculture in 2015 called FAO to coordinate international work on sustainable bioeconomy.

#### Mr. Mathieu Lamolle, Senior Advisor, International Trade Centre



After working as an ethnobotanist for more than a guarter century he now leads the Bioprospecting Economy work of SANBI, working closely with the National Department of Forestry, Fisheries and the Environment (DFEE). This is through diverse efforts: revision of Bioprospecting, Access and Benefit-Sharing (BABS) legislation, development of the environmental component of a certification system for South Africa, Biodiversity Management Plans, Non-Detriment Findings, resource assessments, and the implementation of harvesting quidelines. He works closely with stakeholders, including industry associations, to promote the sustainable use and development of plants from South Africa, and also with international initiatives (e.g. ABioSA, BIA) that sustainably develop the local biotrade and bioprospecting industries. He has a special interest is in realising the conservation of biodiversity through Access and Benefit-Sharing mechanisms.



## **Mr. Soundrapandi Jeyaram**, Project Officer – UNDP, National Biodiversity Authority, India

Mr. Soundrapandi holds an M.Phil and a Ph.D in Botany with specialization in Plant Taxonomy from the University of Madras. Since 2012, he is at the National Biodiversity Authority (NBA), Chennai, India in various capacities viz., as Expert Consultant (2012-15) under Biological Diversity Rule 12(6); Project Officer (2015-18), Gol-UNDP Biodiversity Finance Initiative; and Project Manager (2018-2020), ASEAN-India Cooperation Project under the ASEAN-India Green Fund (AIGF). Suhel al-Janabi, with German and Arab roots, is an expert in biodiversitybased value chain development at the interface to the Convention on Biological Diversity and it's Nagoya Protocol. He is among other duties Co-Manager of the ABS Capacity Development Initiative which he has accompanied since its foundation in 2005 and lead technical advisor of the BMZ funded BioInnovation Africa Project. He followed the CBD process since 2000, from 2006-2014 as a member of the German negotiating delegation. He studied Geography, Ecology, and Economics and taught at the University of Bonn and Abidjan. He worked for several worldwide operating organizations, such as the German Foundation for International Development (DSE), Gesellschaft für Internationale Zusammenarbeit (GIZ) and the Bonn Convention under the UN Environmental Programme (UNEP-CMS). He is a member of the Advisory Committee on Communication of the UN Convention on Biological Diversity (CBD CEPA IAC) and the IUCN Commission on Education and Communication (IUCN CEC). In addition, Suhel acts as Executive Director of GeoMedia GmbH, a consulting for Environment, Communication and Development, based in Bonn. One regional focus of his advisory activities is Africa and the MENA Region.
