In addition, the Panel will devote a full day for discussions on the CSTD's 10-year review of the implementation of the World Summit on the Information Society (WSIS) outcomes.

Findings and recommendations of the Panel are expected to be considered at length at the eighteenth session of the CSTD, to be held in May 2015.
