Objective. The National Training Workshop on Science, Technology, and Innovation (STI) Park Policies and Practices for sustainable development aims to build the capacity of Uzbekistan's policymakers and STI park practitioners in designing and implementing STI park policies and managing STI parks, considering the needs and policy recommendations that are identified and proposed in the analysis paper prepared by the UNCTAD for Uzbekistan under this project. The three-day workshop from Thursday, 14 November 2024 to Saturday, 16 November 2024, will cover essential topics that relate to an efficient and effective ecosystem for STI parks, such as policy coherence, financial sustainability, transfer/commercialization of research or innovation incubation/acceleration, outreach/attracting investment, and tenant support. Through lectures, case studies and group discussions, participants will develop practical skills to support Uzbekistan's STI park initiatives.

**Цели семинара.** Национальный учебный семинар по паркам науки, технологий и инноваций (STI) для устойчивого развития направлен на повышение потенциала политиков и заинтересованных сторон Узбекистана в проектировании и управлении STI-парками. Трёхдневный семинар с четверга, 14 ноября 2024 года по субботу, 16 ноября 2024 года охватит важные темы, такие как финансовая устойчивость, поддержка резидентов и инновационные экосистемы. Лекции, примеры и групповые обсуждения помогут участникам приобрести практические навыки для поддержки инициатив STI-парков Узбекистана.

**Target audience.** This national workshop will bring together policymakers from relevant government agencies, STI park practitioners (including technology parks, incubators, accelerators and industrial parks or free trade zones that also host technology and innovation companies), researchers, and academics engaged in STI policymaking, technology transfer/commercialization of research or innovation outcomes.
