**Ms. Shamika N. Sirimanne** is the director of UNCTAD's division on technology and logistics. She also serves as the head of the secretariat of the United Nations Commission on Science and Technology for Development.Ms. Sirimanne has extensive experience in development policy, research and technical cooperation gained from international organizations, national governments, think tanks and universities. Previously, she served as a director at the UN Economic and Social Commission for Asia and the Pacific and led the economic policy team at the UN Economic Commission for Africa. She also worked for the Canadian Department of Finance and the World Bank. She holds a PhD degree in economics.

**Mr. Torbjörn Fredriksson** heads the ICT Policy Section of UNCTAD's Division on Technology and Logistics. He is responsible for the E-commerce and Digital Economy work programme, which involves among other things the Digital Economy Report, the eTrade for all initiative, various capacity-building activities, and the Intergovernmental Group of Experts on E-commerce and the Digital Economy. He joined the UN in 2000. Before joining UNCTAD, he held positions at the Invest in Sweden Agency and the Swedish Ministry of Industry and Commerce. He has an MSc in International Economics from the Stockholm School of Economics.

**Ms. Esperanza Magpantay** is the Senior Statistician of the ICT Data and Statistics Division of the International Telecommunication Union's Telecommunication Development Bureau, where she has been working since 2000. She is responsible for the collection, harmonization and dissemination of ICT statistics, particularly through the Yearbook of Statistics, the World Telecom/ICT Indicators Database, the ICT Eye and the ICT Development Index. Ms Magpantay is ITU's representative at the Partnership on Measuring ICT for Development and its Steering Committee and the UN Inter-Agency and Expert Group on SDG Indicators (IAEG-SDG). She also coordinated the pilot project of the ITU on Big Data for Measuring the Information Society. Before joining ITU she worked for seven years at the International Labour Office (ILO) in Geneva as a statistical officer. She has a degree in statistics from the University of the Philippines.

**Ms. Barbara D'Andrea** is Acting Chief of the International Trade Statistics Section of the Economic Research and Statistics Division (ERSD) of the WTO. She co-chairs with the OECD the UN Inter-Agency Task Force on International Trade Statistics and is the Inter-Agency Coordinator of Technical Assistance and Statistical Capacity Building in trade statistics.
