## **Background**

- The Working Group was established in May 2020 (first meeting 27th May)
- 15 Meetings organized between the establishment and the submission of the proposal to the IAEG-SDG's.
- 21 members (NSO+DevCo) & 4 observers: Brazil, Germany, Korea and the Netherlands



## **Objective**

- Further develop and refine the measurement of development support in line with the 2030 Agenda under target 17.3 "Mobilize additional financial resources for developing countries from multiple sources".
  - Consider different components of development support, understanding development support
    in a broad sense of the term and including components other than ODA, such as other official
    flows, private finance, international public goods for sustainable development, and SouthSouth and triangular cooperation; the working group will consider, but not be limited by,
    work already conducted to develop measures of these components;

- Continuous reporting to the IAEG SDG's; update to the UNSC's 52<sup>nd</sup> session
- Presentation of the proposal to the 12<sup>th</sup> Meeting of the IAEG SDG's (11.2021).
- Submission and discussion of the Indicator Proposal within the 53<sup>rd</sup> Session of the UNSC (03.2022).
- Overwhelming support for the indicator proposal (oral and written statements by member states).

#### **G77+ China Statement (UNSC 53):**

- The group is pleased to note the progress made so far on the development of the indicator 17.3.1 comprising FDI, ODA and SSC as the proportion of GNI, the group is also satisfied than in line with the principles and unique characteristics of SSC now for the first time there is a global voluntary conceptual framework to measure SSC for SDG target 17.3,
- In this regard the group urges for clear description of the mandates of the co-custodians OECD, UNCTAD to avoid overlaps, and future work to take the indicator as well as the establishment of capacity development initiatives allowing to strengthen future reporting, The group also supports that UNCTAD becomes responsible for future global reporting of SSC.

#### MIC's Statement(UNSC 53):

- A model where cooperation partners recognize the complex realities of developing countries, especially for middle-income countries, in analyzing their strengths and weaknesses backed by evidenced-based and quality and reliable data and statistics.
- In addition, the Group recognizes the progress in the development of the Conceptual Framework for the measurement of South-South Cooperation. We appreciate that the framework was elaborated with a strong leadership of developing countries, further consulted with countries engaged in South-South and triangular Cooperation, and further recognize its alignment with BAPA+40.
- We therefore invite interested countries **involved in South-South cooperation activities to engage with UNCTAD through the report of information and participate in the planned capacity building activities** allowing for a strengthening of the conceptual framework, which will undoubtedly have a significant contribution to the monitoring and implementation of the Sustainable Development Agenda

### Decision 1: Data and indicators for the 2030 Agenda for Sustainable Development (Item 3a); 53rd UNSC

- Adopted the proposed new indicator 17.3.1 and commended the Working Group on Measurement of Development Support for its **transparent process**; requested OECD and UNCTAD to be the co-custodians of the new indicator and to work closely to avoid duplications; and agreed to dissolve the Working Group as it has completed its mandate.
- Noted that further developments of the proposal should **build on the deliberations held and progress achieved in the Working Group**, ensuring stability of the indicator, while noting that the sub-indicator on mobilized private finance is being proposed on an experimental basis and needs further work;
- Welcomed the development of an initial conceptual framework for the measurement of South-South cooperation, and requested that further
  work on this, including on global reporting and capacity building, be enabled by UNCTAD's co-custodianship and led by countries from the
  global South, building on country-led mechanisms, and included under indicator 17.3.1 in the future; invited countries involved in
  South-South cooperation to work closely with UNCTAD

#### **XYZ Declaration:**
