3. Draft report : some key points (1)

Key points as regards the ICT landscape and the Information Society since WSIS:

- ICTs reach much more extensively throughout society and human activity today than they did at the time of WSIS
- Major changes have taken place in ICT technology and markets, including:
 - mass market mobile telephony and mobile internet
 - social media and user-generated content
 - broadband deployment
 - cloud computing and smart systems
 - big data and the Internet of Things
- These have had profound impacts on development but also raised new challenges

3. Draft report –some key points (2)

- Most people now have access to basic ICTs and make use of mobile phones
- About 40% of the world's population makes use of the Internet
- People have used ICTs to open up new opportunities and play a bigger part in their communities
- Governments have made use of ICTs to address health, education and economic growth
- Investment from private sector: high, but revival of public involvement
- Investment not only in infrastructure but also in content, capacity building





3. Draft report –some key points (3)

- The development in technology and services have transformed the potential scope for implementation of WSIS outcomes since the Summit
- «These trends are critical to understand the implementation of WSIS outcomes since the Summit, and the relationship between the Information Society and the post 2015 Development Agenda».
- They have led to new policy challenges

The rapid evolution of the information society, in particular the scope and reach of ICTs, have changed the parameters for the implementation of the WSIS outcomes.

3. Draft report

Achievements in the implementation:

- Many of the WSIS targets have been achieved, and set the platform for future growth. But there are still substantial gaps.
- There is growing positive experience in the use of ICTs in development, but still variations in the extent to which countries and communities have been able to take advantage of them
- The WSIS Forum and Action Lines have provided a framework for discussion of ICT4D and coordination between stakeholders.
- The actions lines have helped to build a better understanding of the WSIS outcomes, but there are still challenges (Statement on the Implementation of the WSIS Outcomes, 2014)
- Increased emphasis on multistakeholder cooperation
- IGF has become an important annual event in the ICT and Internet calendars
- There are still complex issues of internet governance that need to be resolved.



3. Draft report – some challenges in the implementation

- The continuing and evolving digital divide, particularly where broadband is concerned
- The unpredictability of change, which changes opportunities and raises challenges in areas such as cybersecurity
- Mainstreaming ICTs in development and the Post-2015 Development Agenda
- The need for better monitoring and measurement of WSIS outcomes and Information Society development





3. Draft report – some suggestions

Some suggestions concerned with improving the process of WSIIS implementation:

- Forward-looking targets and improved data gathering and analysis
- Focus in Action Lines on new developments in ICTs and on the gender dimension
- Integration of WSIS outcomes in UNDAFs and strengthening the work of UNGIS
- Renewed attention to financial mechanisms
- Achievement of consensus concerning the future of Internet governance
- Development of understanding and building on experience of multistakeholder cooperation
