Purpose

 Purpose of the project was to reinforce synergistic linkages between green trade and sustainable development in the MSG countries

NTM data collection

Review Vanuatu's Coconut Oil Voluntary Sustainable Standards (VSS) since the previous study on "Assessment of Organic Certification in the Coconut Oil Value Chain"

Have a Vanuatu Virgin Coconut Oil Export Guide

Propose policy recommendations

Findings for the NTMs

- 73 regulations introduced NTMs (both principal and subsidiary legislation)
- 276 NTMs were identified and classified
- I7 different ministries and departments were involved.
- The number of regulations and ministries is similar to other MSG countries.

Findings for the VSS review

- Key barriers in the coconut sector:
 - Lack of certification awareness
 - Market novelty and regulation
 - Quality improvement needed
 - Market access and infrastructures
- Recommendations:
 - Facilitate third-party organic certification through cost subsidies and in-country auditing.
 - Establish a national body to manage organic certification.
- Additional Areas of Action:
 - Government-supported education on certification and sustainability.
 - Centralized resource for market access and export guidance.

Vanuatu Virgin Coconut Oil Export Guide

 The export guide aimed to provide a detailed approach to address NTM and Sanitary and Phytosanitary (SPS) barriers associated with exporting VCO. The goals were to enhance awareness among potential exporters, strengthen logistical and supply networks, and revitalize the coconut industry through increased export of quality coconut oil.

Policy recommendations – based on NTMs and VSS

•Vegetable Oil Quality: Revise the Food Act to include CODEX Standard for named vegetable oil.

Sustainable Agriculture: Align GAP (Good Agricultural Practice) code with international standards.

Data Streamlining: Publish trade regulations on a regular basis

Expected impact

Achieve Vanuatu 2030 – The People's Plan (SOC 6; ENV 1, 2; ECO 1, 2, 3, 4) and Vanuatu National Coconut Strategy 2016-2025 and the SDGs under the 2030 Agenda, sustainable practices, and enable green trade.
