

Context: Climate Change and LDCs



LDCs:

- 46 countries, 1 billion people
- Emit less than 1% of the global CO2 emission per year
- On average, a person living in LDCs emit 0.319 tonnes of CO2 a year, than that of person living in high income countries who on average emit 10.926 tonnes
- Frontline of the climate crisis, suffer the most
- Even at 1°C warming- devasting impacts cyclones, floods, destroy crops, properties, public infrastructure, lives and livelihoods
- Over last 50 years, 69% of the worldwide deaths caused by climate related disaster were in LDCs
- Trap in the vicious cycle of poverty

LDC Group Efforts

- Progressive Group, leadership on climate ambition and action
- Pushed for 1.5°C goal of the Paris Agreement, 1.5°C special report by IPCCC
- Consistently call for countries to delivery 2030 targets in line with 1.5° pathway and long-term strategies that map the path towards net-zero by 2050— Closing the Emission Gap 2030
- Launched LDC Vision- 'To be on climate-resilient development pathways by 2030 and deliver net-zero emissions by 2050 to ensure our societies and ecosystems thrive' 2019.
- LDC initiatives LIFE-AR, REEEI and LUCCC
- Hosted Thimphu Ambition Summit: Momentum for a 1.5°C world, 2020
- Scale up climate finance for adaptation and building resilience
- Support for loss and damage and access to finance

What can we do together - Climate and Trade

- Collaboration, cooperation and coordination is key
 - Connect all involved: Parties, Supra National Agencies, NGOs, Businesses, Farmers
 - Transparent and inclusive processes delivering environmental justice
 - Policy options, incentives, technology transfer and financing geared towards environmental outcomes
- Potential areas for collaboration to contribute to overall emission reduction
 - Framework for Traded and Consumption Emissions; Carbon Border adjustment
 - Standards and Certification measurement, reporting and certification of carbon footprint
 - Sustainable Production and Consumption SDG 12 Incentivizing reducing carbon intensity of production and raw materials – Circular Economy concepts for use and end of life cycle recycling
 - Citizens stewardship of environment Create awareness and make it duty bound to consume less
