Measurement and analysis of specific services RVC, prepared by national consultant (June-September)

Project countries and thematic focus

The project beneficiary countries are: Ethiopia and Kenya (for infrastructure services), Gambia and Mali (for tourism services), and Nigeria and Togo (for financial services).

Ethiopia has been investing heavily in infrastructure development (e.g. large-scale transit schemes, dams). It offers insights into a public finance driven process of developing infrastructure services. Kenya, on the other hand, offers insights into a private sector driven process of infrastructure services [Read More](#)
