Technical assistance: STIP Reviews



STIP review of Oman has already delivered concrete results

Oman established a STIP Grand Council for the highest level of political support.

STIP Review presented at Cabinet level.

More than 400 national stakeholders actively participated at the two national workshops held in the course of the review.

STIP review process in Thailand has delivered results

Around 100 stakeholders (from academia, public sector, civil society, and managers of large firms) participated in the National consultation workshop held in Bangkok on 12 December 2014 to discuss the first draft of the STIP Review of Thailand.

A number of strategic STI policy decisions already taken to support Thailand's technological capabilities.

The review will be launched in Geneva during the CSTD.

Technical assistance: ICT trainings

- Trainings on information economy statistics and measurement covering a wide geography:
 - For Ethiopia in Addis Ababa (September 2014)
 - For Lusophone countries in Maputo, Mozambique (November 2014)
 - For CIS countries in Almaty, Kazakhstan (December 2014)
- Regional workshops on e-legislation harmonization

In Dakar, Senegal (February 2014) and Accra, Ghana (March 2014)

Organized in cooperation with the ECOWAS Commission and the African Union Commission for 48 representatives.

In Guayaquil, Ecuador (September 2014)

Organized in cooperation with the Ecuadorian Foreign Trade Ministry, SELA and the Association of Caribbean States for 40 representatives from 20 countries.



Technical assistance: Cyberlaw


Seminar on the harmonization of Electronic commerce laws in ECOWAS organized in Geneva with 40+ delegates

- A platform to discuss best practices to facilitate the implementation of regional legislation on electronic transactions, cybercrime and the personal data protection.
- Also addressed consumer protection, taxation, capacity building and regional cooperation.

Open consultation: An open consultation process was organized for all stakeholders to share their views and experiences on the implementation of WSIS outcomes.

Mandate

- Call for written inputs: Around 100 responses
- Seven consultation sessions in collaboration with United Nations Regional Commissions (including sessions in Abuja, Bangkok, Geneva, Guadalajara, Istanbul [2], and Tunis).

WSIS+10 Review Report

- The inputs contributed to the CSTD Secretariat's Report: Implementing WSIS Outcomes: A Ten Year Review
- The outcomes of CSTD's WSIS+10 review will be submitted through ECOSOC to the UN General Assembly as an input for the GA's overall WSIS+10 review


