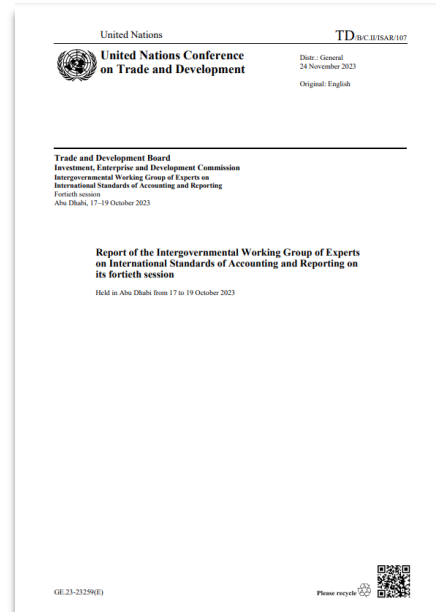

# Eurasian Regional Partnership on Sustainability and SDG Reporting (ERP)

The Partnership was established in response to paragraph 7 of the agreed conclusions of the Report of the Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting on its fortieth session, which includes the establishment of UNCTAD ISAR partnerships in a number of regions, including Eurasia.



The ERP was officially launched on 21.03.2024 at the regional event “Towards Integrated National Financing Frameworks: Implementing sustainable normative tools in Eastern Europe, Western Balkans, the Caucasus, and Central Asia“ organized jointly with UNECE, where UNCTAD (Palais de Nations, Geneva, Switzerland).

## ERP performance results for the period 21.03-03.10.2024

1. The number of ERP participants increased by 70%.
2. One meeting of the ERP members and four meetings of the Steering Committee were held.
3. Regional event “Eurasian Regional Partnership as a platform for promoting sustainability reporting and SDGs” was held on 03.10.2024.
4. Developed a concept and submitted an application with ERP Honours 2024 initiative for participation in ISAR Honours 2024 nomination.
5. ERP Honours 2024 nomination was held.
6. Work was done to find leading initiatives to attract participants to ISAR Honours 2024. On the recommendation of the ERP from the Eurasian region 9 initiatives were submitted for participation in the nomination of ISAR Honours 2024.
7. Two ERP representatives participated in the ISAR Honours 2024 Initiatives Review Committee.
8. The ERP brand-book was developed.
9. A seal for the secretariat was produced.
10. Members of the ERP were issued membership certificates.





## ERP performance results for the period 21.03-03.10.2024

Meeting of the ERP members (03.10.2024, Kyrgyz Republic, Koy-Tash v.):

Decision 1. Members of the ERP were issued membership certificates.

Decision 2. The register of members and observers of the ERP was approved.

Decision 3. UNCTAD-ISAR Regional Partnerships for the Promotion of Sustainability Reporting was adopted as the basis for the ERP. A working group for the development of the ERP founding document was established.

Decision 4. Approved the composition of the Steering Committee: Chairman, Vice-Chairman and Secretariat.

**Chairman** (to 31.12.2025) - SERVICE FOR REGULATION AND SUPERVISION OF THE FINANCIAL MARKET UNDER THE MINISTRY OF ECONOMY AND COMMERCE OF THE KYRGYZ REPUBLIC.

**Vice Chairman** (to 31.12.2025) - MINISTRY OF FINANCE OF THE REPUBLIC OF BELARUS.

**Chairman** (01.01.2026-31.12.2026) - MINISTRY OF FINANCE OF THE REPUBLIC OF BELARUS.

**Secretariat** - EICPA ASSOCIATION.

Decision 5. To start the work on forming the ERP work plan for the period to 31.12.2025.

Decision 6. To hold a regular meeting of the ERP members in the first quarter of 2025.
