- Launch of the CSTD series of open consultations: 10 October 2023, Kyoto, Japan (hybrid)
- Second global consultation: 4
 December 2023, Geneva (hybrid)


Regional consultations


- Arab region: 22 May, Dubai, UAE (hybrid)
- Europe: 17 June, Vilnius, Lithuania (hybrid)
- Asia Pacific: 4 September, Astana, Kazakhstan
- Africa: 11 October, Dar Res Salam, Tanzania
- Latin America: mid November, Santiago, Chile

Findings from the online survey

- A strong focus on issues concerning technology and infrastructure, access and inclusion, and digital priorities such as privacy and data protection.
- Fewer contributions on issues concerning economic, social and environmental development.
- Some responses provided valuable insights into their own countries' experiences while others are in more general terms.

Key messages from hybrid global consultations

- Significant achievements have been made through WSIS.
- The inclusivity of WSIS process (multistakeholder model)should be maintained and extended to digital governance.
- There is common recognition of the value of the IGF and support for renewal of its mandate.
- Universal connectivity and a reliable ICT infrastructure remain a challenge for poor developing countries.
- In digital era, financing for public digital infrastructure and education remains crucial.
- Support to vulnerable groups should be increased.
- International cooperation frameworks should evolve to focus on today's challenge.

Key messages from regional consultations

Arab region

- WSIS helps the Arab region make significant progress in accessibility and affordability of Internet and related services.
- Concerns relate to digital gap, resource constraints, policy and regulatory issues, lack of funding
- Call for support from international and regional organizations to sustain the region's efforts in WSIS implementation

Europe

- Meaningful internet connectivity should be stressed.
- A thorough review and potential update of the current action lines and the Tunis agenda could be conducted while continuing the multistakeholder model and the IGF.
- Concerns relate to the current approach to addressing crucial public policy issues such as AI governance and data flow

Key messages from regional consultations (continued)

Asia Pacific

- Scaling up innovation and enhancing digital cooperation are critical for accelerating WSIS progress.
- 2. Gender inclusion/equity and child online protection should be prioritized.
- 3. New and emerging stakeholders should be in the WSIS process.

Africa

- 1. The Global Digital Compact should be considered in the WSIS+20 review.
- 2. Support to the civil society should be increased.
- 3. African countries need digital infrastructure and skills to benefit from digital technologies.
