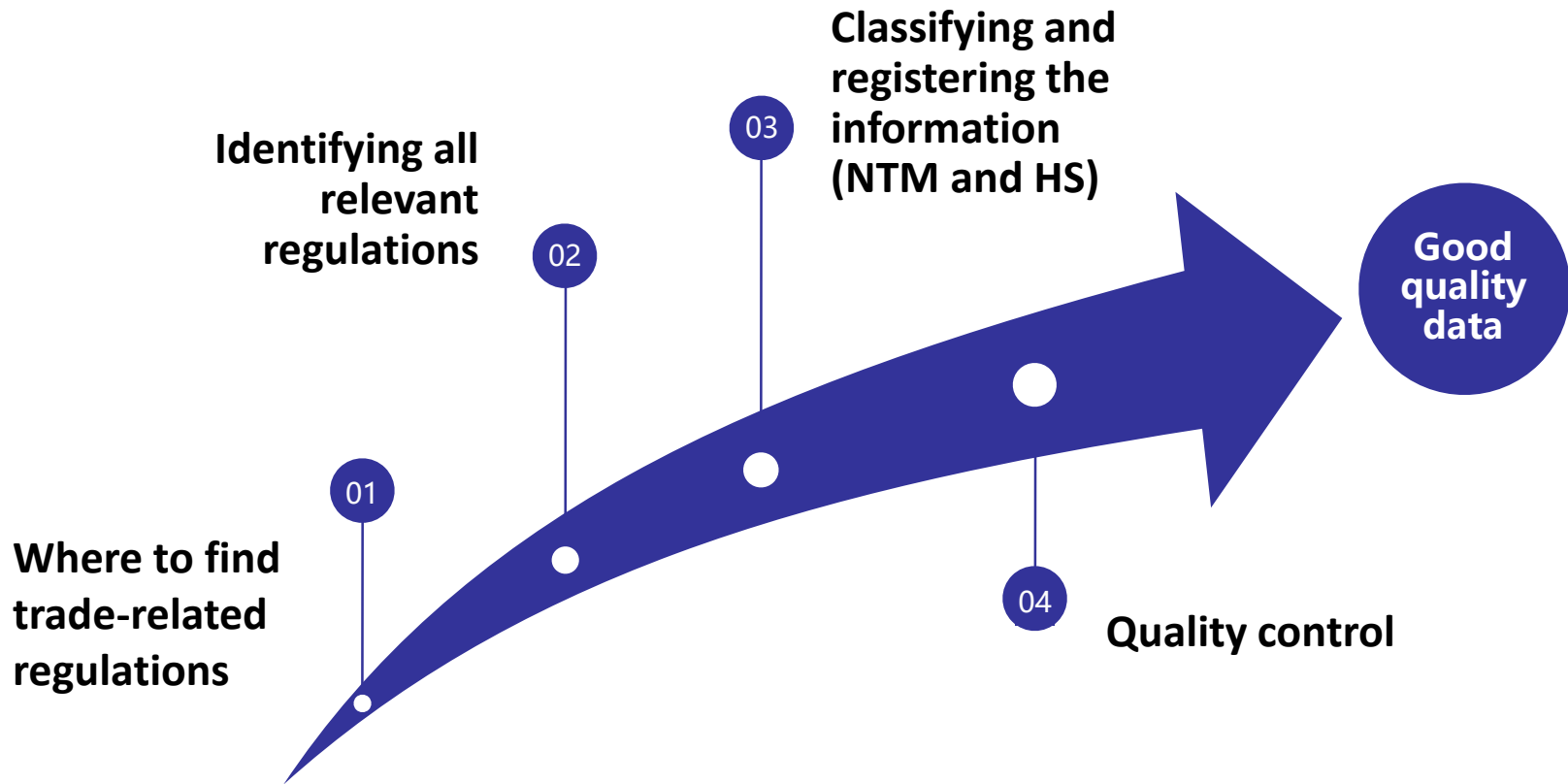

Data collection and update process



Work Flow of the Data Collection



01 Comprehensiveness

- Identifying *all* trade-related regulations of a country is one of the biggest challenges of the data collection – but also one of the most important ones
- Every country has a different institutional framework
- Country-expertise is indispensable, no “one size fits all”-approach

Types of official sources:



Centralized sources/publications

Some countries compile and publish all their laws, regulations, acts, decrees, etc across all government institutions in one centralized publication

Decentralized sources

When a centralized source is missing, regulations need to be obtained from various ministries and institutions that regulate trade (*it is essential to obtain all regulations from each source*)



Other sources

Such as WTO notifications

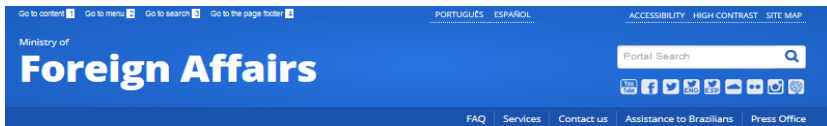

The Latin American Integration Association (ALADI-LAIA)

The Latin American Integration Association (ALADI, its initials in Spanish) was created in 1980 to promote the economic and social development of the region, in a process of integration aiming at a gradual and progressive establishment of a common Latin American market. Currently, ALADI has as its members Argentina, Bolivia, Brazil, Chile, Colombia, Cuba, Ecuador, Mexico, Panama, Paraguay, Peru, Uruguay, and Venezuela. Nicaragua is in the process of accession. The group of 13 members of ALADI covers an area of 20 million km² (nearly five times greater than the area of the 28 countries that comprise the European Union), approximately 530 million inhabitants and a GDP above US\$ 5 trillion.

ALADI is the result of a process of regional integration which started at the end of the 1950s, the first milestone being the establishment of the Latin American Free Trade Association (LAFTA) in 1960. LAFTA was a relatively strict mechanism because it required that any trade concession from a member country to another would be immediately and automatically extended to the others - "the most favored nation clause". This model did not provide the expected gains.

03 Steps in Registering NTMs Information

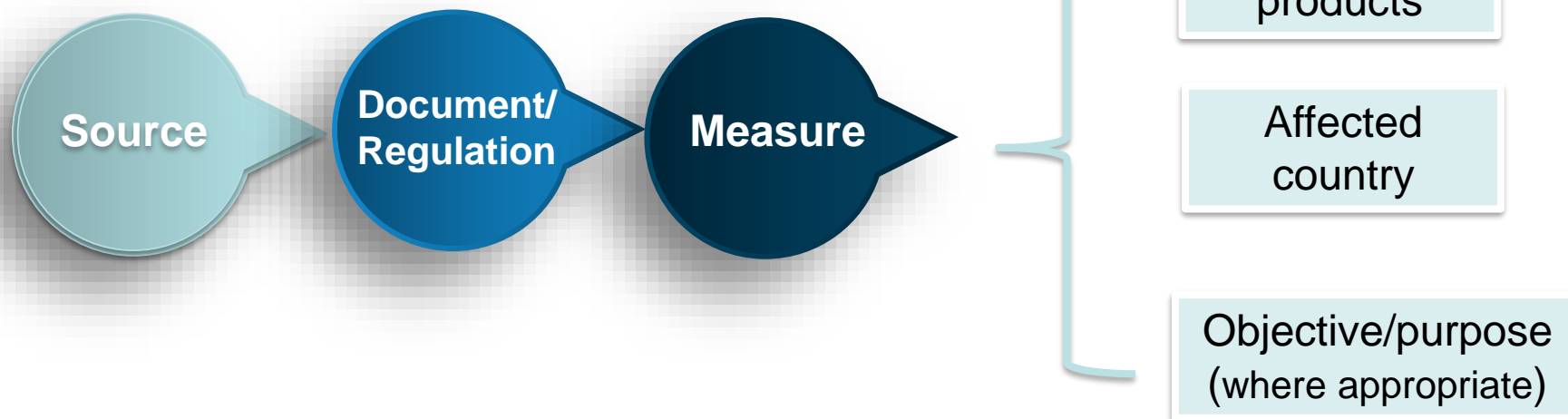
Registering the origin of the data in a systematic way is important

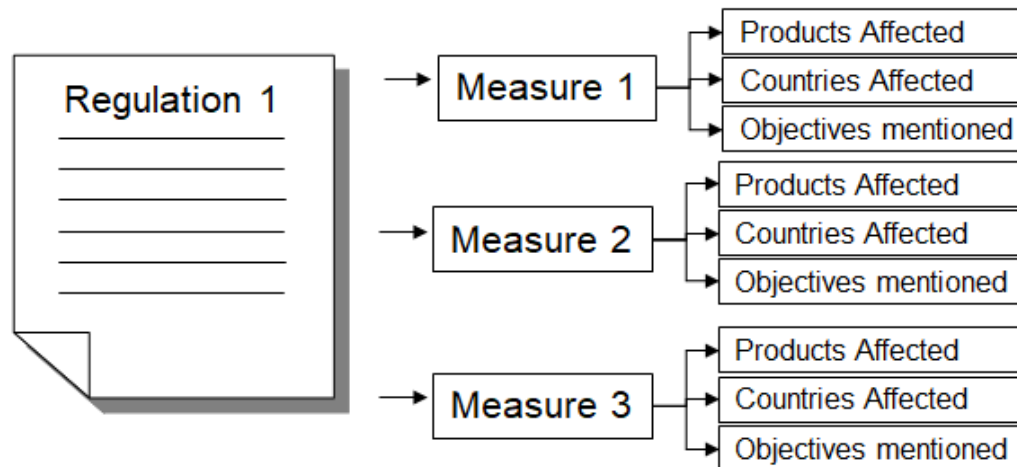

Distinguish a "Measure" with a "Regulation"

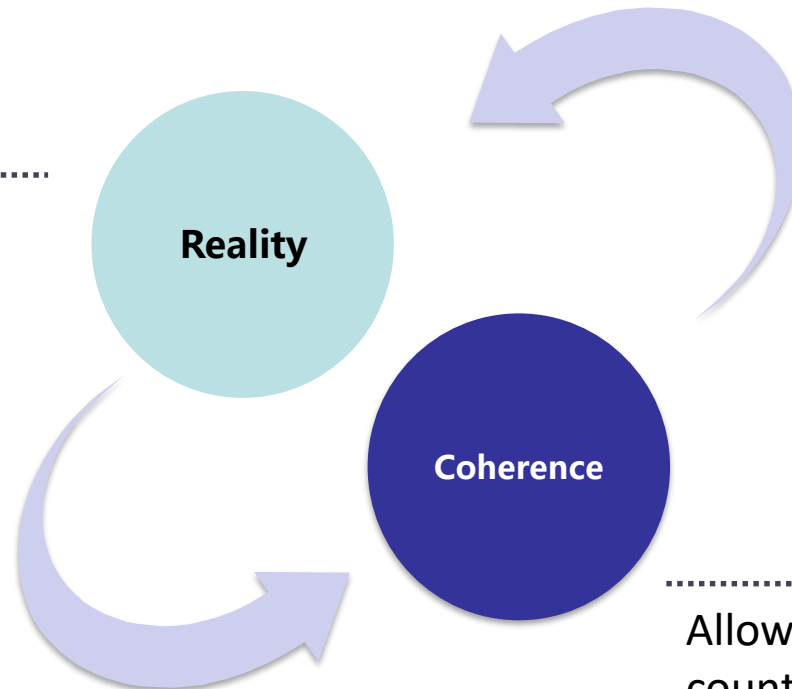
- Regulation → Law, decree, etc. issued officially by a government
- Measure { → Mandatory trade control requirement enacted through such an official regulation
- One official regulation could bear several NTM



Key Principles for Registering NTMs

Global comparable and comprehensive database

Reflects the reality as much as possible



Allows for comparisons across countries, since procedures for data collection are the same



NTM Data Update in ASEAN

• Data

- ❖ Collected at the reporter-year-partner-product – NTM level
- ❖ All trade regulations that were **in force up to March 30, 2018**
- ❖ Include bilateral NTMs and measures applied to the whole world
- ❖ Products are defined for all 10 countries at the **ASEAN Harmonized Tariff Nomenclature (AHTN 2017) at the 8-digit level**

• Methodology

- ❖ Understand legal system of the country (hierarchy of laws and regulations)
- ❖ Identify agencies/institutions issuing trade-related regulations (sources)
- ❖ Collect trade-related regulations from identified agencies (based on the 4 principles)
- ❖ Compare with previously collected data and check for **amendments/newly issued regulations/peals**.
- ❖ Record all changes including **amendments, repeals and newly issued** NTMs in UNCTAD's database

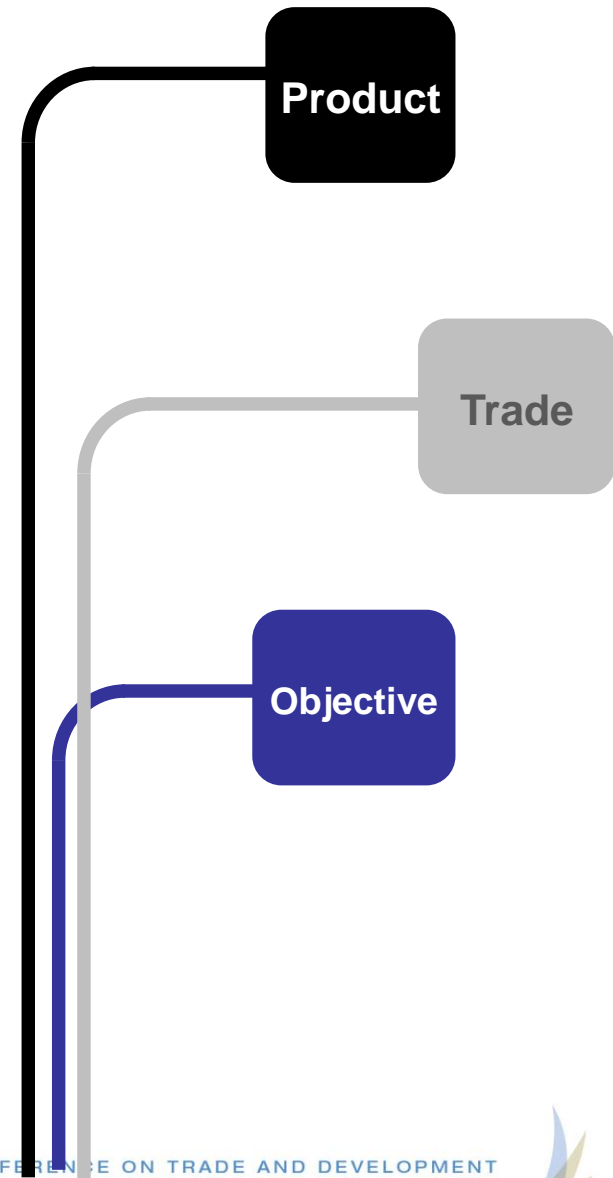

Tree Structure

- Each individual chapter (one digit, letter A-P) is divided into groupings using a tree/branch structure with depth of up to three additional levels (2, 3, and 4 numerical digits).
- More digits indicate more disaggregation – more detailed measure categories.

SPS and TBT: The Differences

SPS measures

10%

- Ensure that **food is safe** for consumers
- Prevent the **spread of pests/diseases** among animals, plants or humans

TBT measures

70%

Standards or mandatory requirements on **product characteristics** or their related **processes or production methods**, including technical regulations, testing and certification procedures

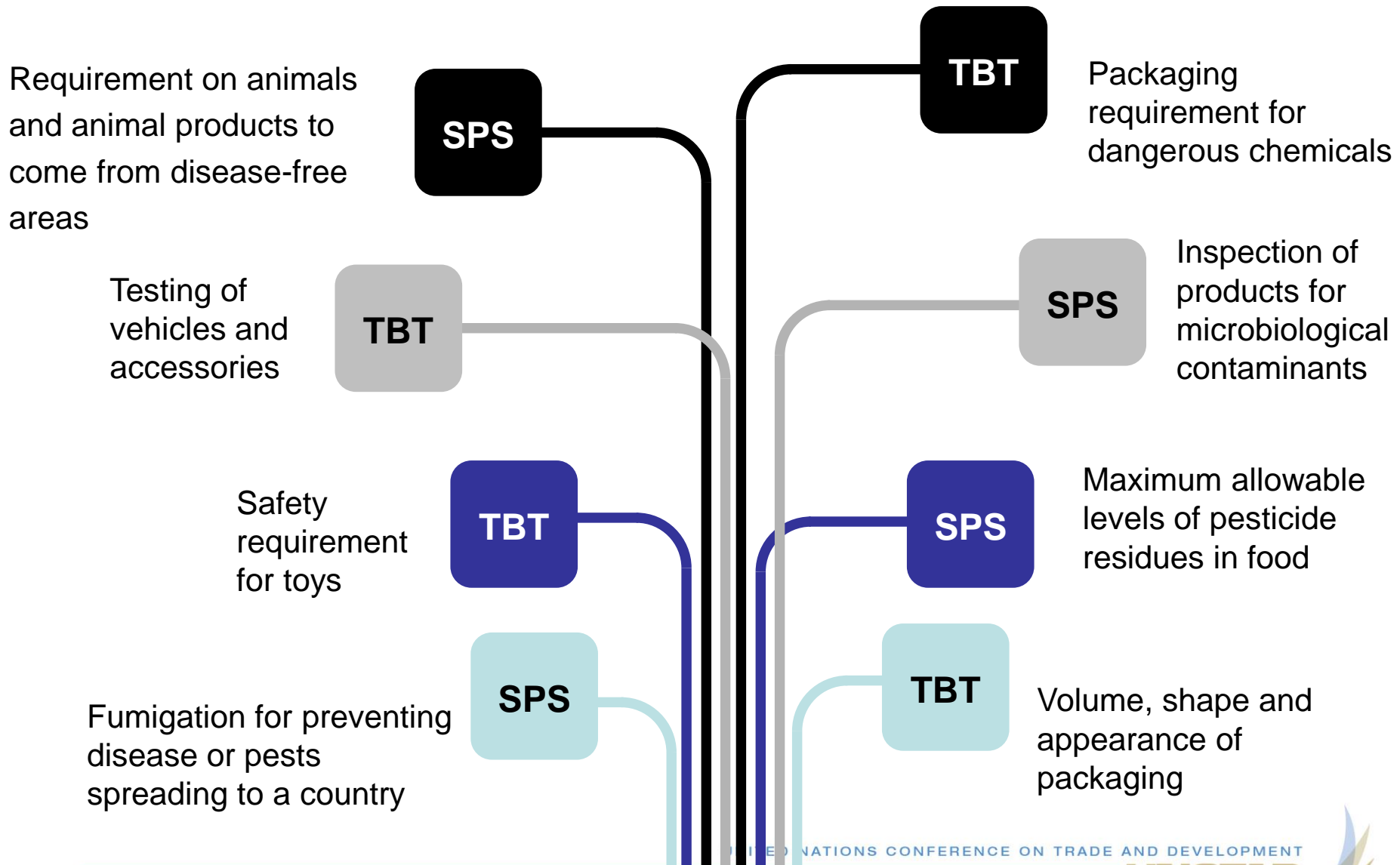
There is no overlap in coverage between the SPS and TBT agreement, it is possible that the same regulation contains both SPS and TBT measures for different requirements, but not possible for one requirement to have both SPS and TBT at the same time (**only exception is labelling requirement**).

02

Neither SPS nor TBT are defined according to product coverage **alone**. It shall be defined by the **objective of the measure plus affected product**.

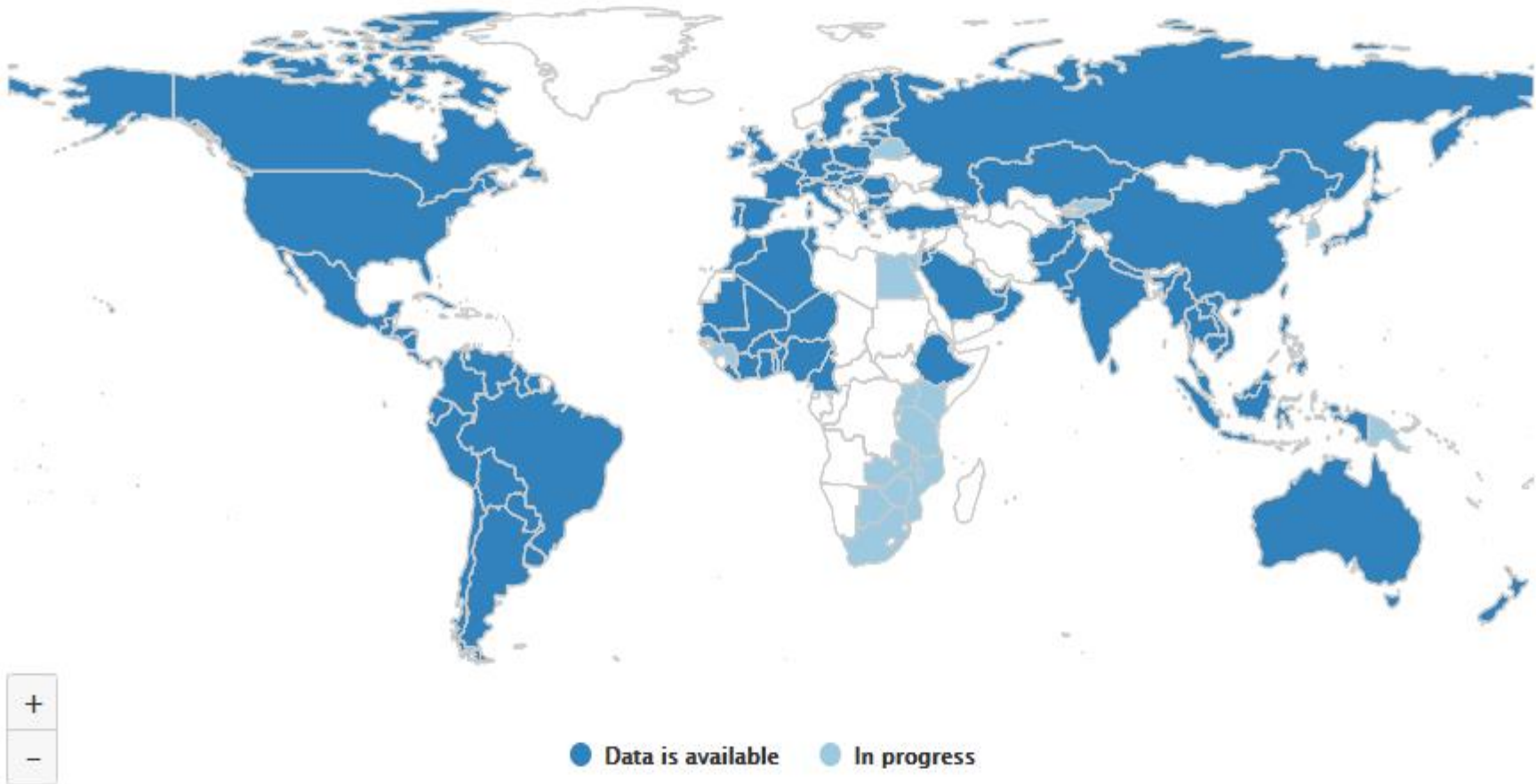

You can download here the NTMs TRAINS researcher file for use in Stata (version 12) containing all non-tariff measures aggregated at the HS 6-digit level by researchers and data analysts. You will also find a file with the names and country codes to expand the data to a fully bilateral structure. The data can easily be used for descriptive statistics as well as for quantitative analysis by merging the file for instance with trade and other datasets.

The data collection follows a standardized and globally coherent approach described in the [UNCTAD Guidelines to Collect Data on Non-Tariff Measures](#). However, the different regulatory practices in each country complicate cross-country comparisons. The user guide provides more information. Furthermore, the highest quality control standards are applied but collecting and classifying NTMs is a very complex exercise so that errors can occur.

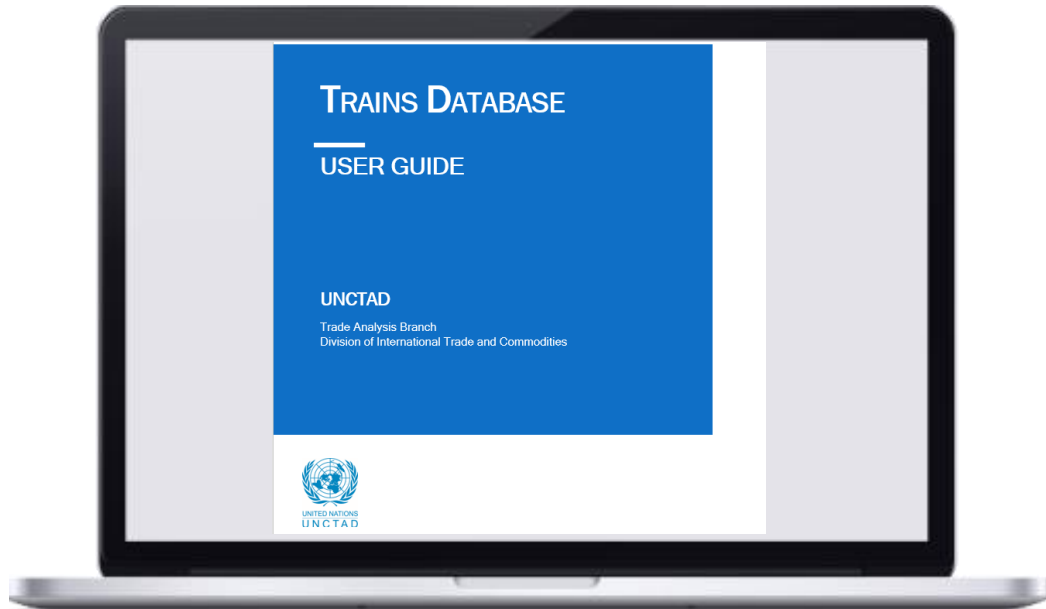
