INEGI is by the Mexican Law the coordinator for the National System of Statistical Information and Geography and also in charge of the Information of National Interest, like GDP and the System of National Account of Mexico. .

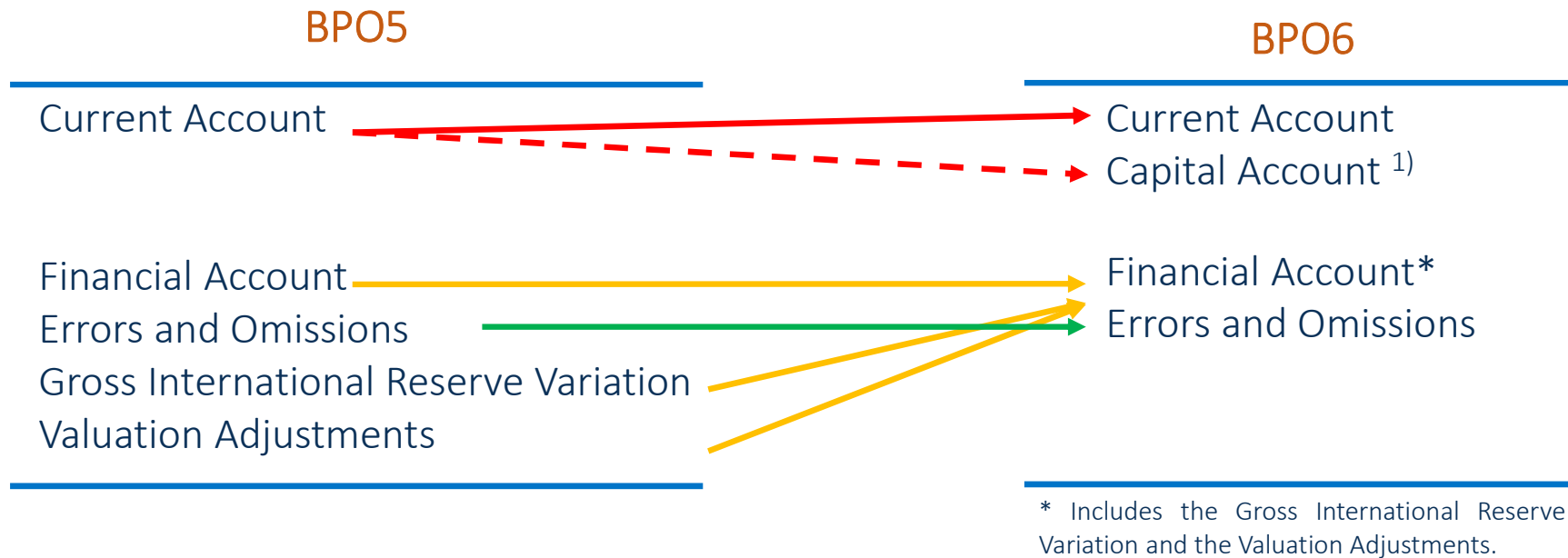
Bank of Mexico, the central bank is responsible for the BOP, and all the items are included in the National Accounts on the Goods and Services accounts and Supply and Use Tables (SUT) and in the Integrated Economic Accounts by institutional sector.

1) Capital transfers are recorded in the Capital Account of MBP6, as well as the acquisition and disposal of non-produced non-financial assets, unlike the Capital Account of MBP4, which conceptually corresponds to the Financial Account of both MBP5, as of MBP6.

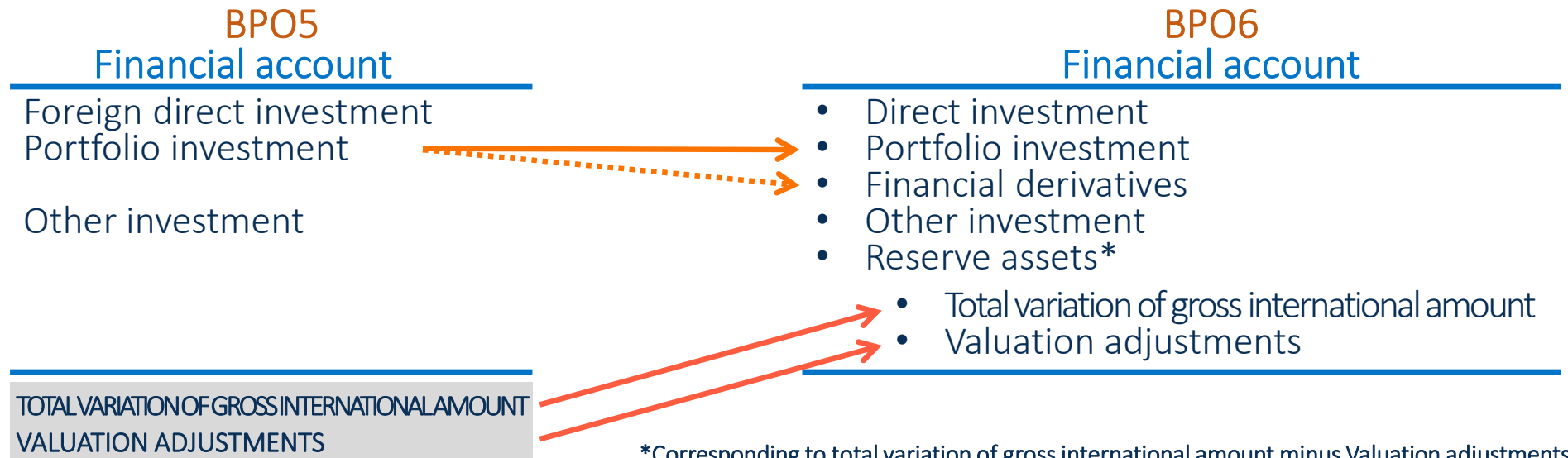

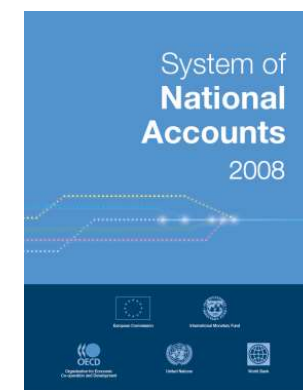

On may 2017, BANXICO published the BOP adopting BOP 6 manual.

The most recent base year on national accounts is 2013, it also adopted the changes in the Banxico BOP and also the SNA 2008 accounting framework, the adoption of BOP 6 manual is one of the main changes that were implemented in the MSNA base 2013 published in October 2017.

**Services mirror statistics in the
intercountry NA TiVA Initiative**

INEGI is in the process of estimating **bilateral trade statistics** for missing services and align **balanced foreign trade statistics** with trade data from national accounts for the NA TiVA project with USA and Canada for an Intercountry NA region SUT.

Estimation of bilateral trade statistics for missing services

- To **compile** detailed statistics on **bilateral trade** in services is a big challenge.
- At the international level, there are substantial **differences** between **countries** in the availability and level of detail.

UNITED STATES

- Publishes **statistics on trade in services** with the world, as well as approximately 88 business partners per country or region.
- In some cases, the **extended balance of payments services** (EBOPS) offer more detailed data.

In the case of **bilateral services** trade reported by the **United States** with **Canada** and **Mexico**, about **9 main categories** of **BPM6** and **39 subcategories** are available.

Canada publishes trade statistics for services with the world, its bilateral trade in services with the **United States** and **Mexico** is available in **three main categories**/¹

The **Bank of Mexico** reports trade statistics of services with the world in **8 categories**/², also through surveys, reports on bilateral trade in travel services with **Canada** and the **United States**.

It is expected a reduction in trade statistics asymmetries and also the improvement in data sharing and exchange.

Extended Supply-Use Tables

One of the main challenges arising from globalization is about generation of official statistics that provide information on the interdependencies and impacts between countries.

Responding to the challenge about measuring the global economy the OECD, as well as the WTO, have identified, at least, the following needs:

A policy for a macroeconomic vision at an industrial and firm-level based on estimates on globalization.

Statistics oriented to integrated and harmonized business statistics with macroeconomic accounts.

Global Manufacturing Exports Value Added (VAEMG)

INEGI as an alternative for implementing the BOP6 in terms of net Exports of Goods for Processing has compiled a series of Global Manufacturing Export Value Added (VAEMG) in a way that is consistent to most recent methodologies in the subject. This is the equivalent to manufacturing services and Mexico is very specialized into this industry.

Analysis of the commercial transactions of the Administrative Records of Foreign Trade 2013.

Census Information Analysis to identify companies with foreign capital participation.

Linkage of Foreign Trade records with Economic Census and surveys to obtain the classification of export and import economic activities.

Application of the HS-NAICS correlation table to the Imports and Exports of goods by item.

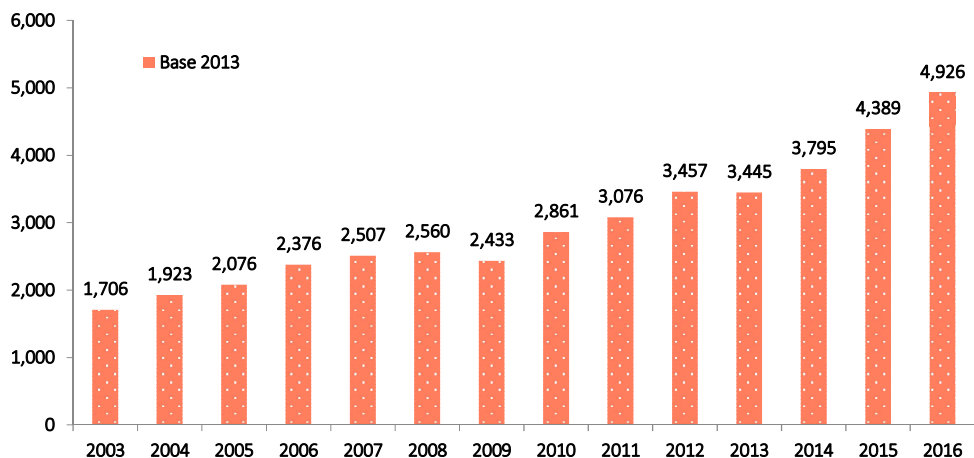

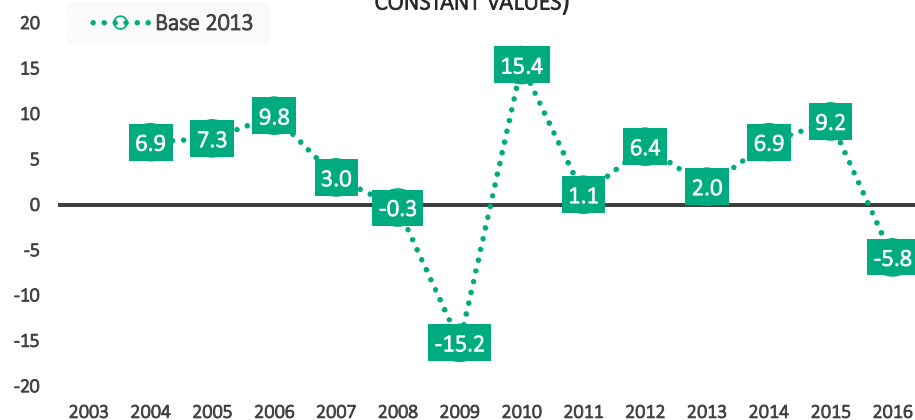

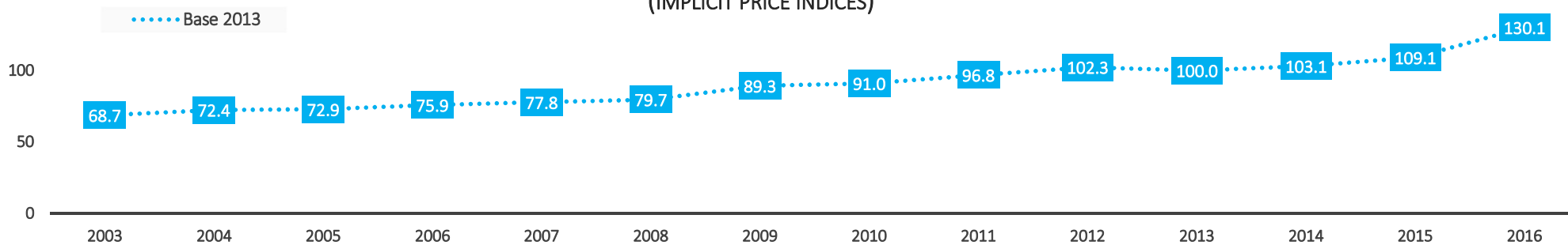
Sector 31-33 Manufacturing Industries Value of Global Manufacturing Production (Billions at Current Prices)

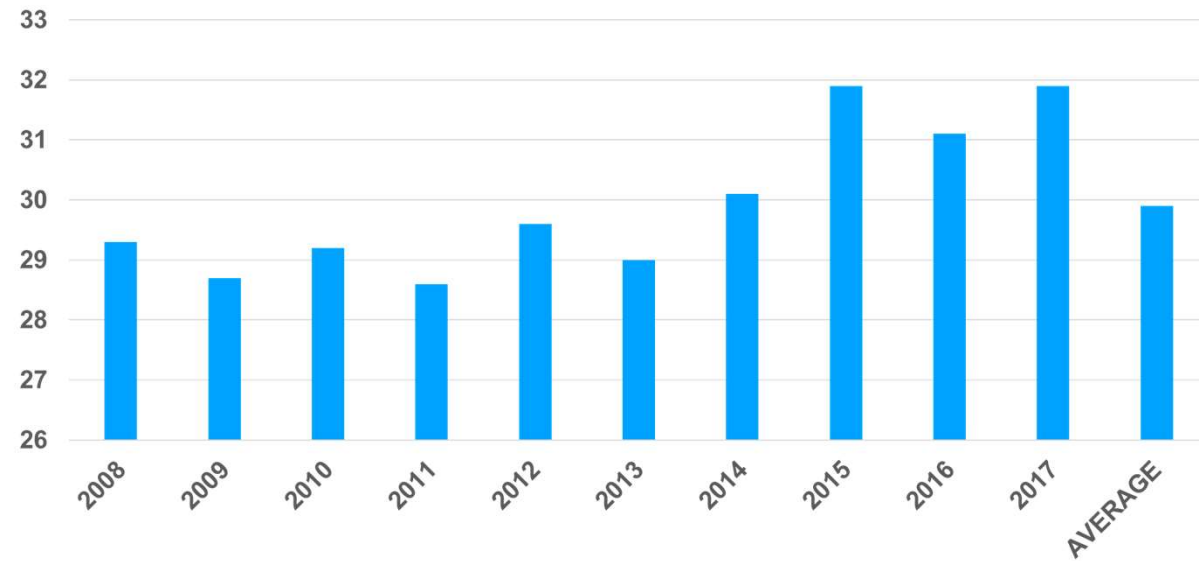
