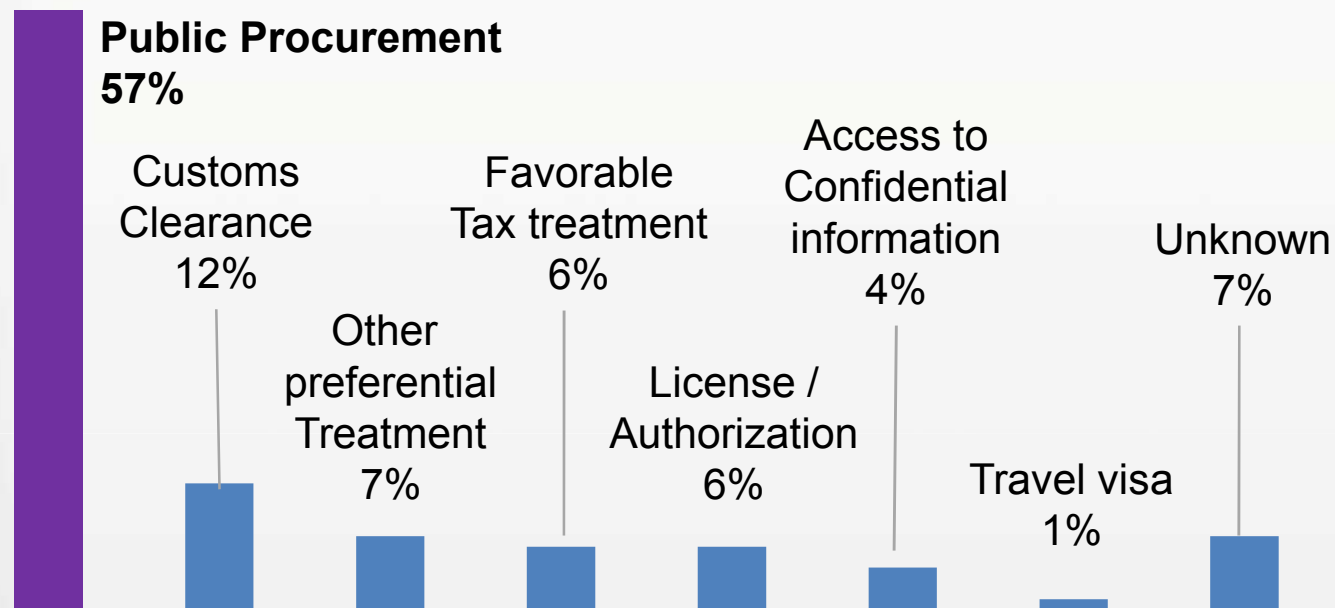
Major Issues in Public Procurement

due to corruption and inefficiency in the public procurement.”

■ OECD Highlights Several Principles;

- Transparency, Stakeholder Participation
- Access to public procurement contracts, Oversight and control
- **e-procurement**



■ Different goals to different people

- **Strengthen national economy**
 - support SMEs, facilitate new industries, etc.
- **Protect our environment**
 - reduce carbon emission, consume more green products, etc.
- **Help the socially vulnerable group**
 - create more job opportunities, provide market access, etc.

■ e-Procurement is an essential tool

- **Provide useful and up-to-date information**
- **Simplify and effectively monitor procurement process**

Long Road to KONEPS



**EDI
(1997~2000)**

Paper documents → e-Documents

- XML-based standard e-Document Interchange for procurement process

**e-Bidding
(2000~2001)**

Physical bidding → Online e-Bidding

- Year-round training at 23 training centers across the country
- Process integration for user convenience (e-Certificates, online fee payment)

**e-Payment,
e-Guarantee (2001)**

Government check → e-Fund transfer

- Payment via electronic fund transfer (EFT), e-certification for guarantee deposit

KONEPS (2002)

Integrated Services through a single portal

- **Entire procurement process** through a single portal

Features of KONEPS



Single window for public procurement

- All bids required to be published on KONEPS
- Bidders can participate in all public biddings after one-time registration

Integration of Entire Procurement Process

- Digitalized end-to-end procurement process from requisition to payment

One-stop service

- 475 types of documents handled online by linkage with 221 external systems (government & private sector)



Transactions through KONEPS (FY2017)



Over 71.2% of Korea's total public procurement(\$123 billion) was conducted through KONEPS

User Registration

- 52,395 government agencies
- 373,833 registered businesses

e-Bidding

- 71.2% of total procurement procured via KONEPS
- 33M people participated in 296T e-bidding
- Total transaction value : \$87.7billion

e-Contracting & e-Payment

- 855T contracts are electronic(99% of all contracts)
- 100% of all payments are electronic

Online Sopping mall

- 1M Purchase Orders issued online(99% of all POs)
- Total e-Mall transaction value : \$17 billion

Impact of KONEPS



Increased Efficiency

- Improved work efficiency through shared data & process automation
- Transaction cost savings of US\$ 8B annually
 - ✓ Private Sector: US\$ 6.6B
 - ✓ Public Sector: US\$ 1.4B



Improved Transparency

- E-disclosure of procurement information on real-time basis
- Enforced user's compliance with existing legislation
- Increased traceability of all transactions (price, specs, etc.)



Economic & Business Development

- Served as a catalyst to expanding e-commerce
- Contribution to development of SMEs
 - ✓ 75.6% of total procurement volume awarded to SMEs

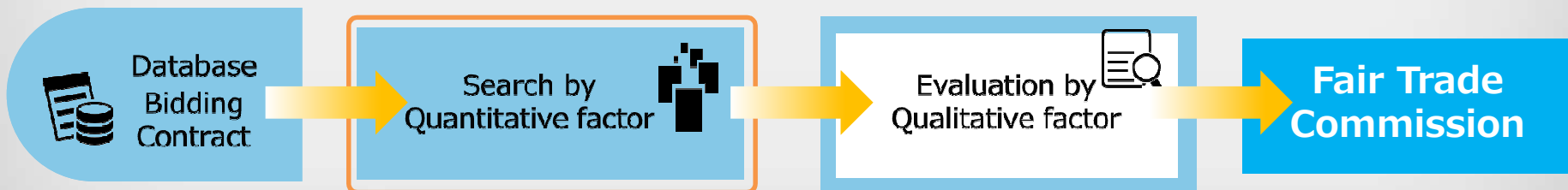

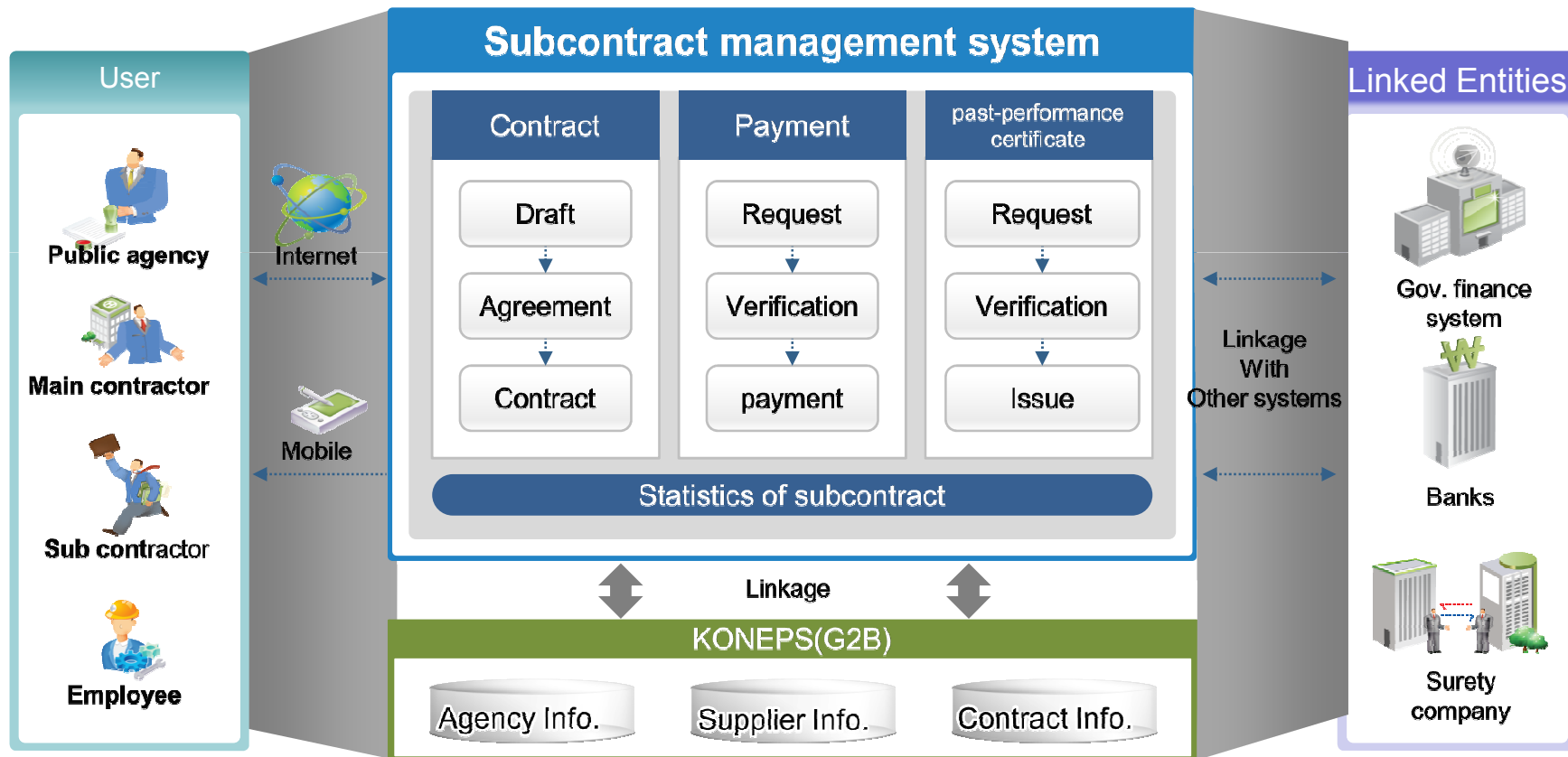
