#### **Meeting Summary**

In recent years, due to the speed of digital development, there has been an increased focus on the digitalisation of cross border movements of goods and the simplification of administrative processes. Port Community Systems (PCS) have been exchanging electronic information in sea and airports for over 40 years, and with the advent of Single Window and the WTO Trade Facilitation Agreement, PCS have become an increasingly important part of making cross border trade simpler.

The meeting will focus on

- Electronic Exchange of Information for Trade Facilitation
  - Clarity on definitions SW, PCS, CCS etc.
  - Integration with Single Window
  - Concept of PCS and CCS
- Logistics Information flows in Trade Facilitation
- Customs information flows and logistics flows integration

The meeting will allow for a presentations on the general concept and development, and will be followed by discussions, questions and answers

### **Speaker Biographies**



#### Richard Morton – Secretary General, IPCSA

Richard spent his early career working in European road, sea and air freight operations.

In 2011 Richard was appointed as Secretary General of the European Port Community Systems Association EPCSA which in 2014 became International, IPCSA. The Association provides a voice for electronic data interchange operators within the complete logistics sphere including air, sea and land. IPCSA, who's global membership now operates in over 150 sea and air ports handling the electronic exchange of information for excess of 500 million TEUs and 8 billion tonnes of cargo. This equates to tens of billions of electronic messages on an annual basis. In his role as Secretary General Richard works to support international organisations on Trade Faciliation including the UN, WCO, WTO, the European Commission, and the IMO. He is also an expert for UNCEFACT and is currently leading the UNCEFACT "Core principles of Single Window Operations" project. and is on the APEC Expert Council on eCommerce.



#### Hans Rook, PORTBASE, Rotterdam, Netherlands / IPCSA, Chairman

Hans has worked in the transport and logistics sea trade sector for 47 years. He started his career at a shipping agency and, having gaining experience in all facets of import and export services, he was appointed to set up the ICT function within the company. He is also one of the gurus on EDI standardisation – he joined UN working groups to establish UN/CEFACT EDIFACT messages for the global sea trade industry. Having been general manager ICT within the shipping agency, Hans was asked to join the Rotterdam group of experts for the set-up of the Port Community System in the Port of Rotterdam. Since then he has been working for Portbase Rotterdam, and he is today Portbase's senior advisor on strategic goals. Portbase is one of the founding members of IPCSA.



#### Uwe Liebschner - Consultant dbh Logistics IT AG / Chairman IPCSA Customs Committee

Uwe has several years of professional experience as an official at the German customs administration. After moving to the private sector, he has now worked for more than 17 years as a consultant for customs and foreign trade at dbh Logistics IT AG in Bremen. The company develop and operate the Port Community System for Bremen, Bremerhaven and Wilhelmshaven. He has extensive experience and knowledge in the fields of the current developments of the EU Customs Code with regard to the implementation of IT projects and their integration into the process flows of logistics and customs clearance. Mr. Liebschner contributes his knowledge for the design of the processes around the logistic handling in the cross-border movement of goods. Furthermore, Uwe Liebschner represents the IPCSA (International Port Community System Association) as Chairman of the IPCSA Customs Committee at various international meetings and events, such as working groups of the EU Commission (DG TAXUD) in Brussels.



### <u>Jalal Benyahoun, General Manager PORTNET S.A.Vice Chair of the African Alliance of E-Commerce, UN/CEFACT Expert</u>

Graduated from Mohammadia School of Engineers and Al Akhawayn University Jalal Benhayoun began his career in 2004 at Groupement pour un Système Interbancaire Marocain de Télécompensation « GSIMT » as a project manager before occupying the position of IT and Operations Manager where he was in charge of the implementation of the National Electronic Gross Mass Clearing System. He then joined in 2011 Fenie Brossette subsidiary of SOMED group as Supply Chain Director. In may 2014 he was appointed General Manager of PORTNET S.A. « National Single Window for Foreign Trade » function that leads him to work in close contact with public and private operators in order to improve and facilitate international trade. Jalal is also Vice Chair of the African Alliance of E-Commerce "AAEC" and UN/CEFACT expert leading the edition of a new recommendation on the core principles of the operation of single window systems. In May 2018, Jalal was elected by the Moroccan Logistics Development Agency as "Professional of the Year" at the 3rd edition of the Moroccan Logistics Awards.
