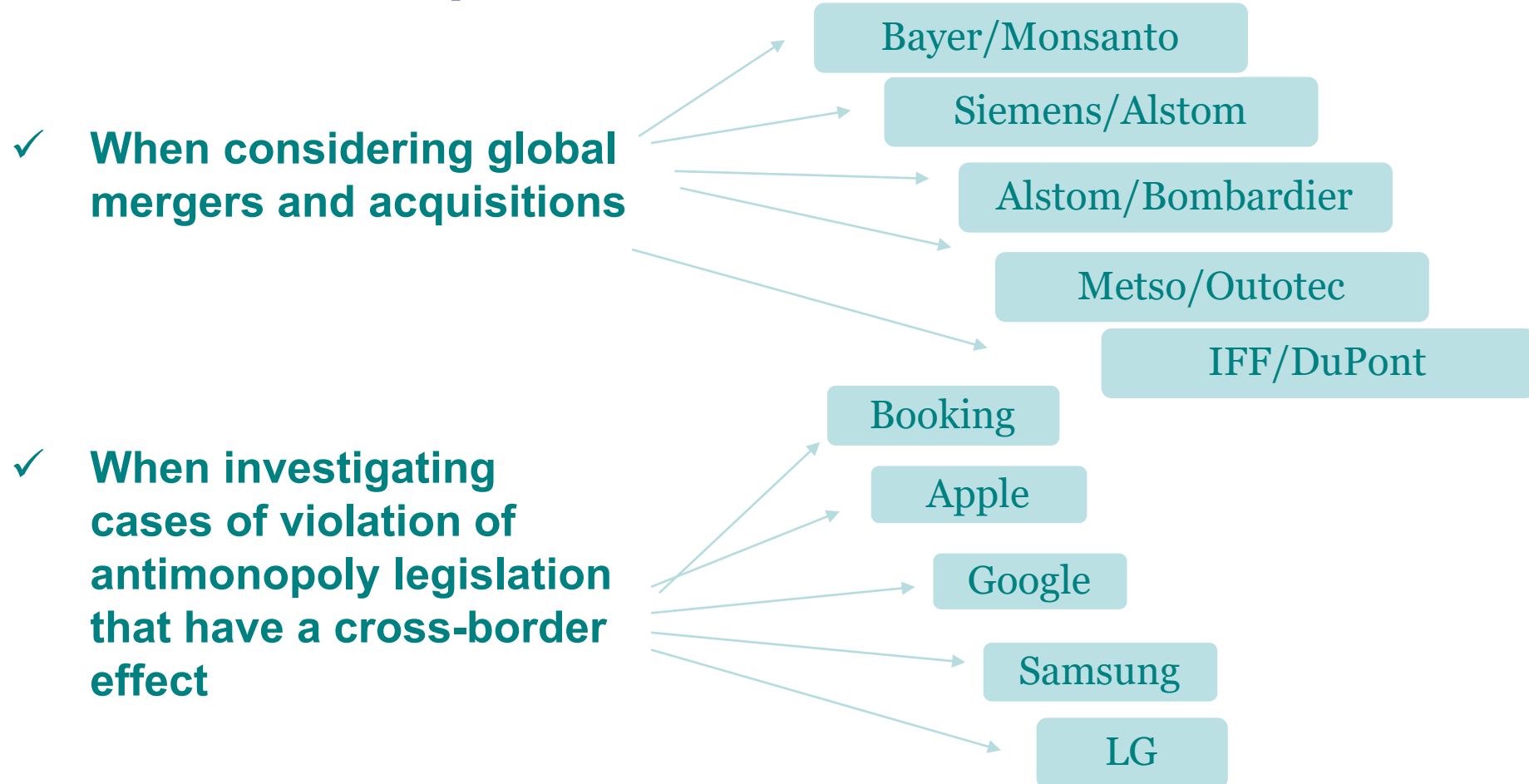

# Guiding Policies and Procedures

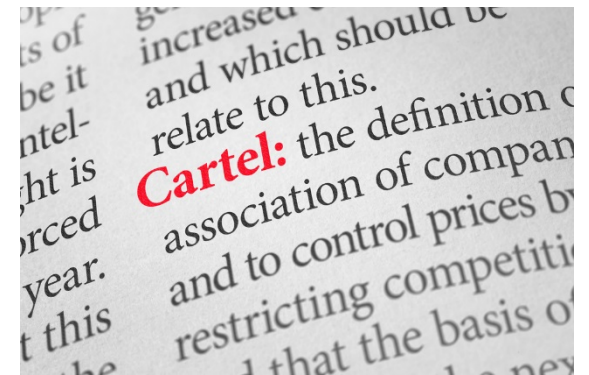
**With the support of dozens of countries and the UNCTAD Secretariat:**



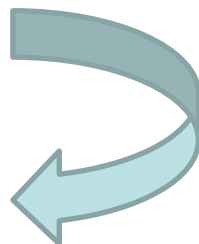
- ✓ The text of **Guiding Policies and Procedures under Section F of the UN Set of Multilaterally Agreed Equitable Principles and Rules for the Control of Restrictive Business Practices** was agreed and approved
- ✓ New document containing tools for international cooperation to counter cross-border violations of competition law
- ✓ **Mechanisms and methods of interaction between competition authorities of both developed and developing countries** in the investigation of specific cases

## Combating cross-border cartels is a priority area for competition authorities

- ✓ **Difficulties in handling cross-border cartel cases** (procedural differences, lack of experience, lack of resources, etc.)
- ✓ **Lack of uniform principles and rules at the international level**, regulating the interaction of competition authorities in the investigation of cross-border cartels



- ✓ UNCTAD that unites 195 countries is designed to help find solutions to the competition challenges faced by developing and poor countries especially



**Development of updated mechanisms for combating cross-border cartels that meet the interests of most countries in the world, regardless of the level of their economic and socio-cultural development**

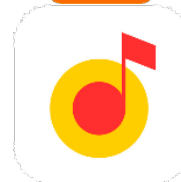
