1	Electricity Act	Regulate the provision of electricity in the country
2	Rural Electrification Act (2004)	Promotion of investment in electricity provision in rural and peri-urban areas
3	Renewable Energy Strategy 2017	Sets out a detailed set of priorities and actions to achieve the following vision for renewable energy in Malawi
4	National Climate Change policy	
5	National Energy Policy	
6	Mining and Mineral Policy act	
7	Independent Power Producers Framework	reforms to the Malawian power sector with the goal of increasing the availability of reliable electricity supply in the country
