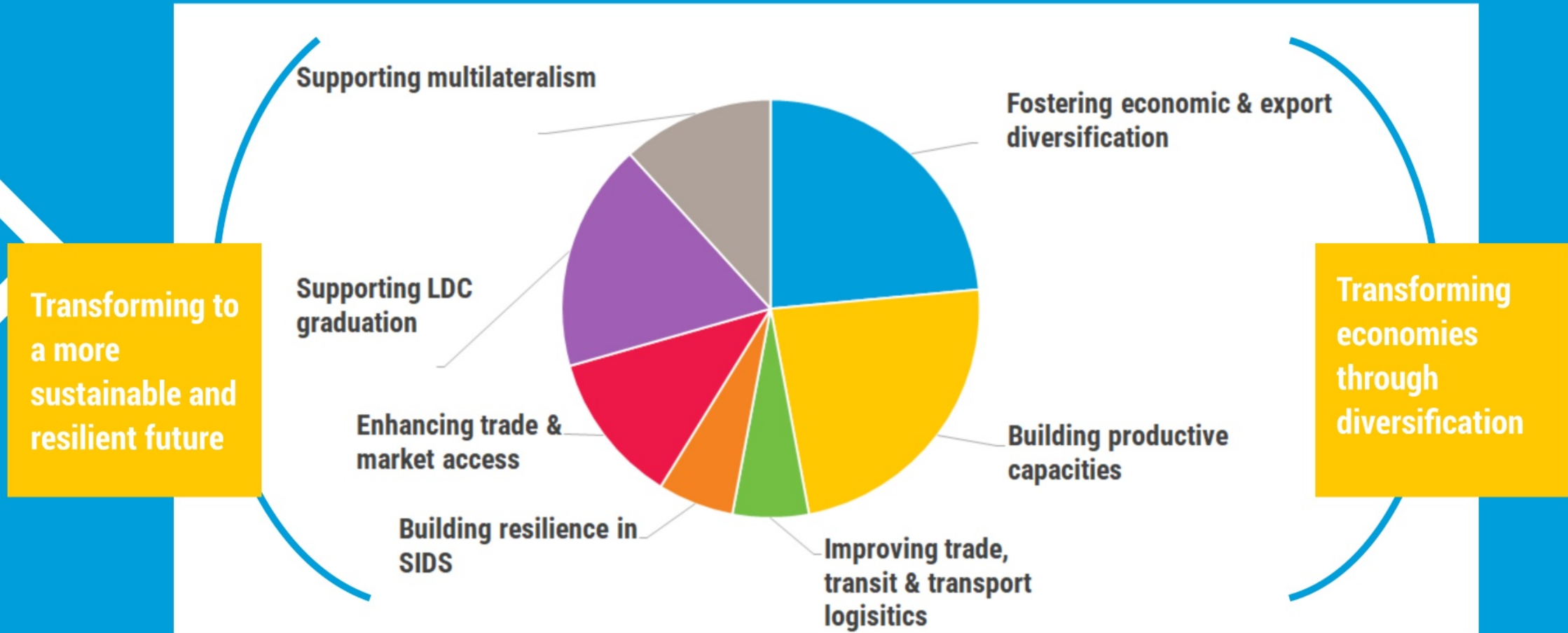

# **Improving trade, transit & transport logistics**

- **Signing of a quadrilateral declaration and roadmap on trade, transit and transport in West Africa by 8 Ministers**

- Developing of innovative tools to assess and monitor the use of trade preferences

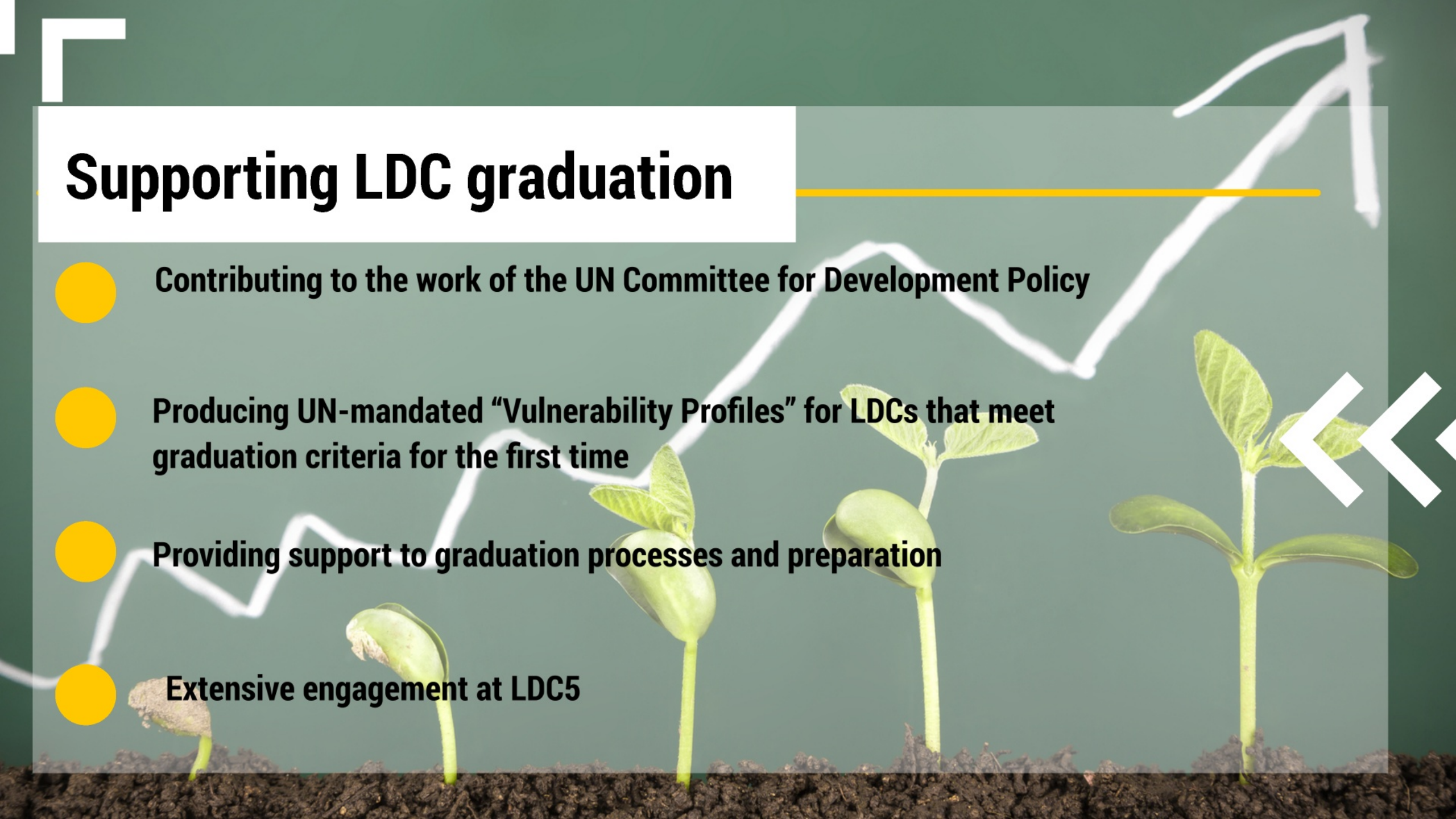
