II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Introduction

1. At its first session, the Intergovernmental Preparatory Committee (IPC) for the Third United Nations Conference on the Least Developed Countries provided that formal consideration of the draft Programme of Action for the Third United Nations Conference on the Least Developed Countries would be undertaken at the beginning of 2001. In the light of this, at its fifty-fifth session, the General Assembly decided, inter alia, to convene the second session of the Intergovernmental Preparatory Committee from 5 to 9 February 2001 in New York (GA resolution 55/214).

- 2. The provisional agenda has been drawn up in keeping with General Assembly resolutions 54/235 and 55/214.
- 3. Suggestions for the organization of work and a tentative timetable of meetings are annexed to these annotations.

7. The Executive Secretary of the Conference will present an oral report on the progress made in the preparations for the Conference. Information will be made available by the secretariat on specific events of the Conference, including interactive debates, civil society and parallel events, and the participation of non-governmental organizations in the Conference and in the final session of the IPC. The Committee may also wish to consider arrangements for its final session and other inter-sessional meetings.
