EU-UNCTAD joint Programme for Angola: Train for Trade II

The Government of the Republic of Angola and the United Nations Conference on Trade and Development (UNCTAD) have agreed to organize a high-level launch of the EU-UNCTAD joint Programme for Angola: Train for Trade II, in Luanda from 11 to 13 April 2018. The programme has the objective of reinforcing the institutional and human resources capacity of Angola for policy formulation and implementation and related areas, such as finance, technology, tourism and transports.

The high-level launch of the programme of support is organized in two phases: policy (or political) and technical. At the policy level, it intends to raise political awareness about the project components and implementation strategies; enhance coordination on the implementation of the project components; and mobilize all the relevant stakeholders for the full implementation of the EU-UNCTAD Joint Programme for Angola: Train for Trade II.

The second phase of the launch (technical level) will focus on technical consultations with all publicand private-sector Angolan stakeholders on the content, implementation strategy and the action plan for each of the project components. The specific project areas are: i) trade policy and negotiations (commercial diplomacy); ii) trade facilitation and transport logistics, iii) investment policy review of Angola; iv) SME development and export promotion; and vi) scoping non-oil trade opportunities/diversification; vii) creative economies. In addition, it will discuss with the National Steering Committee on subsequent implementation phases and validate the consolidated action plan implementation methodologies.

The high-level launch is a crucial stage of the coordinated implementation of the EU-UNCTAD joint programme of support for Angola, which was signed by the Government of Angola and the European Union in 2014 and by UNCTAD in 2016.

UNCTAD is designated to implement key components of the project, with a focus on strenghen the human resources capacity of Angola in the areas of international trade, trade facilitation and logistics, investment and enterprise development. This includes providing tailored trainings to Government officials, private sector actors and academia in areas previously identified by Angolan counterparts as relevant to their efforts to achieve long-term growth, sustainable development and economic diversification.
