13:30 – 15:00	<p>Session 3 – Exploring comparative advantages and identifying sectors with potential for export diversification</p> <p>There are comparative advantages for several African countries, both within the extensive and intensive margins, for export diversification and structural economic transformation. For several LLDCs and structurally vulnerable economies of West Africa, the extractive sector, agriculture and agro-processing are promising sectors for export diversification. There are also growing opportunities in terms of export markets for West African products including China, South Africa and Russia. Therefore, based on the studies undertaken by CSEA, this session explores the potential existing in the sub-region, binding constraints and policy challenges limiting exploitation of existing comparative advantages for trade expansion, economic growth and development.
