II. ANNOTATIONS TO THE PROVISIONAL AGENDA

Item 1: Election of officers

- 1. In accordance with rule 18 of the rules of procedure of the main Committees of the Trade and Development Board, the Commission shall elect a Chairman, five Vice-Chairmen and a Rapporteur from among the representatives of its members, taking into account the need to ensure equitable geographical distribution. Rule 19 of the rules of procedure states that the Bureau of the Commission shall consist of seven members (i.e. four members from Lists A and C combined, two members from List B and one member from List D referred to in the annex to General Assembly resolution 1995 (XIX) as amended).
- 2. Accordingly, following the cycle of rotation established after UNCTAD IX, the bureau for the fourth session of the Commission shall be as follows: Chairman from List C; Rapporteur from List A; and five Vice-Chairmen (2 from lists A and C combined, 2 from List B and 1 from List D).

<u>Item 2</u>: <u>Adoption of the agenda and organization of work</u>

- 3. The provisional agenda for the fourth session of the Commission, as reproduced in section I above, was approved by the Commission at its third session on 2 October 1998 (TD/B/45/10, annex I).
- 4. Concerning the organization of the work of the session, the Commission will have five days available to it. It is suggested that the agenda items be taken up sequentially, with the first plenary meeting on Monday, 20 September, being devoted to procedural matters, introductory statements and the commencement of the discussion under item 3. The last plenary meeting, on Friday, 24 September, would be devoted to the formal action under items 3 8.
- 5. The secretariat will prepare a detailed programme for the session, which will be made available on the first day of the session.

- Item 3: Analysis of factors affecting the production and trade of commodities, such as the implications of financial crises, the reasons for and effects of the collapse in commodity prices, and the impact of changing distribution and market structures
- 6. This item will help to examine factors affecting the commodity sector, particularly in developing countries, focusing on those elements which appear to have increased in importance

in recent years. In this respect, it will be possible to discuss both the fundamental changes in the structure and functioning of the world commodity economy, and the dynamics of price movements in the light of financial crises.

7. It will also provide an opportunity to consider possible areas for international cooperation. These areas could include improving the ability of enterprises in commodity-dependent developing countries, in particular LDCs, to function successfully in increasingly complex markets; enhancing market transparency, information flows and analytical capacities; eliminating trade-distorting practices; making the international "playing field" more equitable for smaller and weaker participants; promoting structured commodity finance and the use of price risk management instruments; and measures to promote vertical and horizontal diversification in commodity-dependent developing countries.

Item 4:

Analysis of certain service sectors, including analysis of successful experiences in those sectors, particularly those which enhance the export capacity of developing countries (such as professional and business services and access to transport services), including the development implications of electronic commerce

8. This item will provide an opportunity to examine successful experiences in service strategies, both in strengthening the domestic services sector and in increasing exports of services. Experiences with liberalization of trade in services and the prerequisite conditions to maximize the development impact of such liberalization will be examined. The effective implementation of export strategies requires an identification of barriers to trade in services, and the negotiations under GATS XIX will provide an opportunity to pursue their elimination. Regional integration agreements among developing countries should be deepened to facilitate exports of services to neighbouring countries. The growth of electronic commerce has provided new challenges and opportunities for developing countries in designing such strategies and penetrating world markets for trade in services, as well as mastering the new negotiating issues that it entails.

9. At its third session (TD/B/COM.1/22, para. 22), the Commission requested the secretariat to prepare jointly with WTO an assessment of the impact on developing countries of liberalization under GATS. The Commission also requested the secretariat to prepare, in

cooperation with WTO, a list of economic needs tests in the schedules of specific commitments under GATS. The two studies will be made available to the fourth session as background papers.

<u>Item 5</u>: <u>Reports of the subsidiary bodies of the Commission</u>

- 10. In accordance with paragraph 114 of "A Partnership for Growth and Development" (TD/378), subsidiary bodies should report technical matters discussed at the expert level to the parent Commission, which may transmit them to the Board as appropriate. The Commission will have before it the reports of the three expert meetings held since its third session. The Commission will consider their findings and discuss the policy implications. In taking note of the reports, the Commission may wish to endorse the agreed conclusions contained therein. The Commission should, when appropriate, make the results of its expert meetings available to other relevant Commissions.
- 11. In addition under this item, the attention of the Commission will be drawn to the report of the ad hoc expert meeting on applications of structured commodity finance techniques for commodity-dependent countries.
