Item 1

Election of officers

1. It is recommended that the Multi-year Expert Meeting on Trade, Services and Development elect a Chair and a Vice-Chair-cum-Rapporteur.

2. The substantive topic for the twelfth session of the Multi-year Expert Meeting on Trade, Services and Development was approved by the Trade and Development Board through a silence procedure that ended on 15 December 2025.¹

Item 3

Servicification for economic diversification

3. The twelfth session of the Multi-year Expert Meeting on Trade, Services and Development will focus on servicification for economic diversification. The meeting will provide an opportunity for experts to exchange views and good practices on how servicification is an important means to pursue structural transformation, productivity growth, economic diversification and enhanced resilience. At the meeting, trends and examples of servicification across countries will be presented, and discussions will focus on the impact of recent trends on digitalization, knowledge-intensive services and trade policy, including opportunities and challenges for developing economies.

4. Sessions of the Multi-year Expert Meeting Trade, Services and Development examine the role of trade in services in supporting economic diversification, consistent with the Geneva Consensus (TD/561/Add.2). In paragraph 21 of the Geneva Consensus, the “growing significance of services as a new frontier for structural transformation, particularly for developing countries seeking to diversify their economies” is underscored. The discussion will be in line with the objectives of paragraph 80.14 of the Geneva Consensus on promoting productive activities in developing countries through trade in services.

5. To facilitate discussion, the UNCTAD secretariat has prepared a background note entitled “Servicification for economic diversification” (TD/B/C.I/MEM.4/35).

6. Under the agenda item and as a follow-up to requests from member States in previous sessions of the Multi-year Expert Meeting, at the twelfth session of the Multi-year Expert Meeting on Trade, Services and Development, a segment of the discussion will be dedicated to data needs and gaps related to servicification. How improved data can enhance understanding of servicification and support policymaking will be explored, notably in the area of trade policy, to enable developing economies to harness servicification for economic diversification and development. Findings from the discussion will align with the objectives of paragraph 80.15 of the Geneva Consensus on improving the collection, accessibility and use of services trade data to inform policy decisions.

7. Member States are invited to nominate experts from the public and private sectors. Nominated experts are encouraged to participate in all sessions of the Multi-year Expert Meeting on Trade, Services and Development to ensure continuity. Each member State is encouraged to nominate up to five experts to participate.
