High-level segment: Launch of the revised United Nations guidelines for consumer protection

This high-level segment will focus on the adoption of the revised United Nations guidelines for consumer protection. Panellists will review the guidelines and discuss national experiences in implementing the directives.

The revision of the guidelines has a long history. Consumers International has been advocating a comprehensive revision since the mid-1990s. Early efforts resulted in the addition of a chapter on sustainable consumption in 1999 (annex III of the guidelines). Many additional areas require revision and current projects in this regard are ongoing.

UNCTAD is the United Nations agency responsible for the guidelines. A resource manual describing UNCTAD management of the revision is available. Key participants are identified and information is provided on how Governments, intergovernmental organizations and Consumers International have been engaged in the process. In particular, the role of ad hoc expert groups is explained, including the recent formation of specific working groups to further undertake revisions. Finally, the manual indicates when further developments are expected to arise and how Consumers International proposes to influence them.
