On 22 December 2015, the General Assembly adopted resolution 70/186 on consumer protection, including the revised United Nations guidelines for consumer protection and establishment of the Intergovernmental Group of Experts on Consumer Protection Law and Policy to provide the international institutional machinery for the guidelines.

This session will discuss the method of work and work programme for the Intergovernmental Group of Experts on Consumer Protection Law and Policy from 2016 to 2020, when the Eighth United Nations Conference to Review All Aspects of the Set of Multilaterally Agreed Equitable Principles and Rules for the Control of Restrictive Business Practices will be held.

The note by the UNCTAD secretariat entitled "Method of work and work programme, 2016–2020" (TD/B/C.I/CPLP/2; available at http://unctad.org/en/Pages/MeetingDetails.aspx?meetingid=1060) provides some points that the Intergovernmental Group of Experts on Consumer Protection Law and Policy may wish to consider. Discussions will be followed by a session on other issues, to consider the proposal to declare 15 March as the United Nations day of world consumer rights.

To facilitate discussion, the secretariat proposes the following issues:

- (a) Should any improvement be considered of past practices of the Intergovernmental Group of Experts on Competition Law and Policy as proposed in chapters II and III of the note by the UNCTAD secretariat?
  - (b) Which issues should be selected for studies and research in 2016–2020?
- (c) Should there be any modification to the methodology for conducting voluntary peer reviews on consumer protection as proposed in the note?
