

Item 3

Responsible and sustainable business practices and corporate social responsibility and enterprise development

- 3. The Trade and Development Board, at its sixty-fifth session, part II, determined that the topic for this session of the Multi-year Expert Meeting would be responsible and sustainable business practices and corporate social responsibility and enterprise development. The meeting will discuss responsible and sustainable entrepreneurship practices and supporting government policies, including in the context of facilitating entrepreneurship development, as well as entrepreneurship policies to enable economically disadvantaged groups, including women, youth and migrants.
- 4. To facilitate the discussion, the UNCTAD secretariat has prepared a background document entitled "Responsible and sustainable business practices and corporate social responsibility and enterprise development", which reviews inclusive approaches to business and entrepreneurship promotion. The meeting will discuss how the sustainable and inclusive dimension of enterprise development may be enhanced by promoting responsible business practices, corporate social responsibility and inclusive entrepreneurship, to facilitate progress towards implementation of the 2030 Agenda for Sustainable Development. The meeting will review examples of inclusive business models and how awareness of good sustainable and inclusive business practices may be facilitated. In addition, discussions will elaborate on policies aimed at strengthening the role of entrepreneurship in inclusive growth and sustainable development.
- 5. The meeting will also discuss how the UNCTAD Entrepreneurship Policy Framework may be adapted and expanded to address the challenges of sustainable and inclusive growth, including through the creation of employment opportunities and engendering of inclusive outcomes for various disadvantaged groups, such as women, youth, migrants, persons with disabilities and the poor. Policy interventions can play an important role in supporting people from all backgrounds in considering entrepreneurship as a career choice and making it possible for them to thrive. Proposed policy interventions, with specific modifications for promoting inclusive entrepreneurship for sustainable development, are grouped under the six pillars of the Entrepreneurship Policy Framework, namely formulating a national entrepreneurship strategy, optimizing the regulatory environment, enhancing entrepreneurship education and skills development, facilitating technology exchange and innovation, improving access to finance and promoting awareness and networking.
- 6. Finally, an update will be provided of UNCTAD work related to the Entrepreneurship Policy Framework, in Cameroon and Ethiopia, and the meeting will consider practical examples of policy interventions to support women, youth and migrant entrepreneurs in these countries and elsewhere. Finally, experts will suggest a way forward and possible tailored government responses based on needs assessments of each target disadvantaged group.
