The Division on Investment and Enterprise of UNCTAD has made significant progress on preparation for the eighth edition of the World Investment Forum which will take place in Abu

# The Fortieth session of ISAR to deal with very timely financial and sustainability reporting topics

The Fortieth session of the Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting (ISAR) will be held from 17 to 19 October 2023, in parallel to the eighth World Investment Forum, in Abu Dhabi, United Arab Emirates. The session will focus on two very timely main agenda items:

- Review of practical implementation of and recent developments in sustainability reporting requirements; and
- Accounting and reporting needs of micro, small and medium-sized enterprises and the role of accounting and reporting in facilitating the formalization of businesses in the informal sector.

### Applications for ISAR Hours reach a new record

Applications for the 2023 edition of ISAR Honours closed with a record number of 70 applications (46 National, 24 International). In the National category, applications were received from different countries, including 19 from Africa, 8 from Latin America and the Caribbean, 11 from Asia, 2 from the Middle East and North Africa, and 3 from Europe and North America. The applications include initiatives aimed at improving sustainability and SDG reporting, illustrating growing commitment of businesses to the 2030 Sustainable Development Agenda. Honourees will be announced at the ISAR Honours ceremony during the 40th Session of ISAR in Abu Dhabi on 17 October.

# UNCTAD and ACCA organizing a joint symposium on sustainability reporting standards for the public sector

UNCTAD and the Association of Chartered Certified Accountants (ACCA) are organizing a joint symposium on sustainability reporting standards for the public sector, which will take place in Abu Dhabi on 16 October 2023 in parallel to the World Investment Forum. The event will feature prominent experts in public sector accounting and reporting. The symposium will provide an important platform for gaining insights into the approaches the International Public Sector Accounting Standards Board (IPSASB) is considering for developing public sector sustainability reporting standards. It will provide stakeholders with an opportunity to engage with key players in this process and articulate their views.

Participants are encouraged to register early for the symposium and finalize travel arrangements.

# Regional Partnerships for Promotion of Sustainability and SDG Reporting conducted significant activities

The Regional Partnerships for promotion of sustainability and SDG reporting in Africa and Latin America that were established with the support of UNCTAD two years ago conducted significant activities in their respective regions.

The African Regional Partnership for Sustainability and SDG Reporting (ARP) met on 7 July for its second meeting of 2023. The meeting focused on 3 main agenda items including: (1) experiences by member countries on the application of UNCTAD's Accounting Development Tool (ADT), (2) the discussion on the ISSB's consultation on agenda priorities, including a live poll to collect feedback, and (3) discussion on administrative issues, mostly regarding the possibility of organizing an event of the ARP at the World Investment Forum in Abu Dhabi in October.

The Latin American Partnership for the promotion of sustainability reporting (ARL) held its first meeting of 2023 from 1 to 2 March virtually. The meeting had the participation of a representative of the ISSB in charge of the region who provided an update on ISBB activities and plans. A representative of UNCTAD presented a series of policy options that countries can choose from to tackle the sustainability reporting challenge. A representative from IFAC spoke of the education,

skills, and competencies necessary for the Accountancy Professions in relation to sustainability reporting. In addition, representatives from Mexico spoke of the Sustainability Advisory Forum of ISSB, an expert from Colombia shared experience in relation to the new regulation on sustainability reporting that the Superintendence of Finance issued, and Uruguay shared national experience in creating a national alliance to promote sustainability reporting.

The second meeting of the ARL took place in a hybrid format on 17 of July, in the context of the Ibero-American Sustainability Forum for Competitiveness. At the meeting, a representative from ISSB provided an overview of the new standards issues by ISSB, i.e., IFRS S1 *General requirements for disclosure on sustainability-related financial information* and S2 *Climate-related disclosures*. Moreover, the Partnership held an internal consultation to prepare a regional response to the ISSB's Request for Information on its work programme for the coming two years. A representative of *the Brazilian Committee for Sustainability Pronouncements* (CBPS) spoke of the objective, structure and plans of the CBPS and an expert from the Global Reporting Initiative presented GRI's standards, capacity building initiatives and publications.

In 2023, the UNCTAD secretariat has been working with member States in Asia and in the Gulf to establish Regional Partnerships for Promotion of Sustainability Reporting in the respective regions. Two more Regional Partnerships will be launched at the Fortieth session of ISAR and the Eighth Edition of the World Investment Forum in October at Abu Dhabi, United Arab Emirates.

#### **UNCTAD** supporting Uganda with facilitating formalization of MSMEs

On June 30, 2023, the Ministry of Finance, Planning, and Economic Development in Uganda hosted a kick-off meeting for the second phase of the Informality Management for Compliance and Revenue Mobilization (IMCORE) program. The project aims to transform 10,000 small informal businesses into medium, compliant, and attractive entities over a 5-year period, boosting Uganda's economic growth. The United Nations Conference on Trade and Development (UNCTAD) is developing an eAccounting tool designed to provide a free and user-friendly tool for business accounting, formalization and tax compliance.

# UNCTAD publishes a revised training manual on sustainability and SDGs impact reporting

The UNCTAD secretariat published a revised <u>training manual on sustainability and SDGs impact</u> reporting. The training manual contains 34 core indicators on the economic, environmental, social and institutional areas. It is a practical tool, intended for all kinds of users, particularly for preparers of reports by Small and Medium Sized Enterprises (SMEs) who want to start their sustainability reporting journey. The manual provides a definition, measurement methodology and potential sources of information for each indicator. It contains useful illustrative examples of indicator calculations and of how companies have provided disclosures on the indicators. It also includes

self-assessment questions with solutions and a list of selected references to deepen understanding of these issues.

### IFRS Foundation opens ISSB office in China
