Mr. Lashen Ababouch

Lahsen Ababouch, former Director, fisheries and aquaculture economics and policy division at FAO, is currently international consultant for FAO, UNCTAD and SIPPO. He is Professor of food policy at the American University of Rome. He has co-authored some 108 scientific publications, including books and book chapters, and some 184 scientific and technical communications on seafood trade and marketing, sustainability, eco-labelling and certification and value chain analysis. He has wide experience in training, research, technical assistance and capacity building in fish and seafood sustainability and trade, in over 70 developing countries in Africa, the Middle East, Asia and the Pacific.
