



OUTLINE FOR REGIONAL WORKSHOP ON DMFAS V6, FUNCTIONAL AND TECHNICAL TRAINING KAMPALA, UGANDA, SEPTEMBER 1ST TO 10TH 2014

A. Introduction

The latest DMFAS version 6 released by UNCTAD's DMFAS Programme includes several new modules and functionalities to meet debt management offices' needs in different areas. This workshop, organized in collaboration with MEFMI, will train participants on those new modules and functionalities and on selected modules by the participants. During a separate session, which will last over four days and will be organized in parallel to the main course, the workshop will provide training for database/system administrators on installation and maintenance of DMFAS v6.

B. Objectives:

- Provide training on the new modules/functionalities of DMFAS v6 such as Drawing Request, Issuance Authorization, Extended Amendments, new debt service operations (prepayment, buyback, suspension), auditing, etc
- Provide training on modules that are selected by the participants
- Present the development plans of DMFAS v6
- Provide explanation and training on the new Helpdesk Policy in the use of the Helpdesk email account and the TRAC system
- Provide training on DMFAS v6 installation and maintenance procedures



- Provide any required technical or functional clarifications to any country-specific issues through bilateral meetings.

C. Target group

- DMFAS users whose responsibilities include data recording and/or reports and statistics generation.
- DMFAS database administrators for the session on DMFAS installation and maintenance

Country delegations are kindly requested to prepare a presentation lasting 30 minutes on the following topics:

- The challenges in the use of DMFAS 6 in the debt office;
- The challenges in receiving the support from the Helpdesk;
- The modules/functionalities they want to have in the system;

These issues will be discussed with the presenters after each presentation.

These presentations are to be held on day five of the workshop. Each delegation is kindly requested to make available to the organizers of the workshop a copy of the presentation at the latest upon their arrival in Kampala.
