The Committee elected its Vice-Chairman-<u>cum</u>-Rapporteur, Mr. Mussie Delelegn Arega (Ethiopia). The Chairman, Mr. Walter Lewalter (Germany), made a short opening statement on the item. Mr. Rubens Ricupero, Secretary-General of UNCTAD, addressed the Committee. The Committee began its consideration of item 4 with an introductory statement by Mrs. Anna Tibaijuka, Special Coordinator for Least Developed, Land-locked and Island Developing Countries.

Statements were made by the following representatives: Ethiopia (on behalf of the African Group); Haiti (on behalf of the Latin American and Caribbean Group); Finland (on behalf of the European Union); Bangladesh (on behalf of the least developed countries and the Asian Group); Nepal; Sudan; China; Czech Republic; United States of America; Egypt; Japan and Madagascar.
