# SUMMARY OF MEETINGS

25 October 1999

Committee of the Whole

First meeting

Item 2      Preparatory process for the tenth session of the Conference  
- Establishment of the Committee of the Whole

The Committee began its consideration of item 2 with an opening statement by Mr. Rubens Ricupero, Secretary-General of UNCTAD. The Honourable Minister of Foreign Affairs of Morocco, H.E. Mr. Mohammed Benaissa, addressed the Committee to introduce the outcome of the Ninth Ministerial Meeting of the Group of 77 and China held in Marrakech. This was followed by a statement by the representative of the host country for UNCTAD X, H.E. Mr. Krit Garnjana-Goonchorn, Permanent Representative of Thailand.

Statements were made by the following representatives: Finland (on behalf of the European Union); the Islamic Republic of Iran (on behalf of the Asian Group); the Dominican Republic (on behalf of the Latin America and Caribbean Group); Australia (on behalf of JUSSCANNZ, the Republic of Korea, Turkey and Israel); Japan; Switzerland; Third World Network and CIDSE (the coalition of northern Catholic Development agencies).
