923rd plenary meeting

Item 2 - Interdependence and global economic issues from a trade and development perspective: Financial stability: reform of the international financial architecture and the role of regional cooperation

The plenary continued the general debate under this agenda item. Statements were made by the following representatives: European Commission; Senegal (on behalf of the African Group); Egypt; World Bank; Pakistan; Iran, Islamic Republic of; Bangladesh; Bahrain; Cuba; Brazil; and United States of America.

A statement was made by Mr. Mauricio Escanero (Mexico), Facilitator of the Bureau for the Preparatory Committee of the High-Level International Intergovernmental Event on Financing for Development, New York.

The plenary thus concluded its general debate on item 2. Following the general debate, in the afternoon the Board engaged in an informal interactive debate on agenda item 2. The Bureau of the Preparatory Committee of the High-level Intergovernmental Event participated from New York by means of a video conference link.
