Preface

In conformity with General Assembly resolutions 1995 (XIX) of 30 December 1964 and 63/204 of 28 January 2009, the thirteenth session of the United Nations Conference on Trade and Development was held at the Qatar National Convention Centre from 21 to 26 April 2012. The theme and sub-themes of the Conference were approved by the Trade and Development Board at its fifty-second executive session, held 11–12 and 14 April 2011, and the provisional agenda for the Conference was approved by the Board at its fifty-eighth session, held 12–23 and 28 September 2011.

Also at its fifty-eighth session, the Trade and Development Board established the open-ended Preparatory Committee for UNCTAD XIII, to be chaired by the President of the Board, Mr. Anthony Mothae Maruping (Lesotho), in order to consider the pre-Conference negotiating text. At its twenty-fifth special session, held 19–26 March 2012, the Board took note of the report of the Chair of the Preparatory Committee. At its plenary meeting on 13 April 2012, the Preparatory Committee of the Trade and Development Board decided to transmit the draft UNCTAD XIII negotiated text to the Conference.

The pre-Conference events held between 17 and 20 April 2012 included meetings of the Global Services Forum, the Seventh Annual Meeting of the Global Network of Export-Import Banks and Development Finance Institutions (G-NEXID) and the World Investment Forum. The opening ceremony and opening plenary were held on 21 April (see chapter I). A High-level Segment of Heads of State and Government was held on 21 April with the topic “In the wake of the global economic crisis: New opportunities for economic growth with social equity”. The “High-level Event on Women in Development” was held on 23 April. In the course of the Conference, a series of round tables was held on topics related to the sub-themes of the Conference. In addition, ministerial meetings of the Group of 77 and China (TD/468), the Least Developed Countries (TD/462) and the Landlocked Developing Countries (TD/474), as well as meetings of the Civil Society Forum (TD/463), were held in conjunction with the Conference and transmitted declarations to the Conference. At its closing plenary meeting, on 26 April 2012, the Conference adopted the Doha Mandate (TD/500/Add.1) and the Doha Manar (TD/500/Add.2), published as addenda to this Report.

I. Organizational, procedural and other matters

A. Opening of the Conference

(Agenda item 1)

1. The inaugural ceremony of the thirteenth session of the United Nations Conference on Trade and Development was held on 21 April 2012 at the Qatar National Convention Centre, Doha, Qatar. Opening statements were made by His Highness Sheikh Hamad bin Khalifa Al-Thani, Emir of Qatar; H.E. Mr. Moncef Marzouki, President, Republic of Tunisia; H.E. Mr. Issoufou Mahamadou, President, Republic of Niger; H.E. Mr. Ikililou Dhoinine, President of the Union of the Comoros; Ms. Hannah Tetteh, Trade Minister, Ghana, on behalf of H.E. Mr. John Atta Mills, President of Ghana; H.E. Mr. Recep Tayyip Erdogan, Prime Minister, Republic of Turkey; H.E. Sheikh Hasina, Prime Minister of the People's Republic of Bangladesh; and Mr. Abdelkader Bensalah, President of the Council of the Nation, Algeria.

B. Election of the President

(Agenda item 2)

2. At its 281st (opening) plenary meeting, on 21 April 2012, the Conference elected by acclamation as its President H.E. Mr. Hamad bin Abdulaziz Al-Kuwari, Minister of Culture, Arts and Heritage of Qatar. His name was put into nomination by Ms. Hanna Tetteh, Minister for Trade and Industry of Ghana, who made a statement on behalf of President John Atta Mills. Ms. Tetteh noted that, as a representative of the host country for UNCTAD XII in 2008, she was honoured to be nominating a representative of the host country of UNCTAD XIII.

C. Establishment of sessional bodies

(Agenda item 3)

3. At the same meeting, the Conference decided to establish a Committee of the Whole to consider and report on the specific substantive item referred to it by the plenary (agenda item 8). It was recalled that, in line with rule 63 of the rules of procedure, the Committee of the Whole could set up such drafting groups as might be required to carry out its functions.

D. Election of vice-presidents and the Rapporteur

(Agenda item 4)

4. At the same meeting, the Conference decided that its Bureau would consist of 34 members, comprising the President, the vice-presidents, the Chair of the Committee of the Whole, and the Rapporteur of the Conference. It further decided that the composition of the Bureau should be such as to ensure equitable geographical distribution, i.e. seven members from Africa, seven from Asia, seven from Latin America and the Caribbean, nine from Group B, four from Group D, and one from China. 5. In accordance with past practice, the Conference decided that the coordinators of regional groups and chairs of subsidiary bodies would be fully associated with the work of the Bureau.

E. Credentials of representatives to the Conference

(Agenda item 5)

(a) Appointment of the Credentials Committee

6. Also at its opening plenary meeting, and in accordance with rule 14 of the rules of procedure, the Conference established a Credentials Committee consisting of nine members. In accordance with past practice, the Committee was to be composed of the same nine States as appointed by the General Assembly to serve on the Credentials Committee at its sixty-second session. The composition of the Credentials Committee was thus as follows: China, Costa Rica, Egypt, Italy, Maldives, Panama, the Russian Federation, Senegal and the United States of America.

(b) Report of the Credentials Committee

7. At its 286th (closing) plenary meeting, on 26 April 2012, the Conference approved the report of the Credentials Committee, contained in document TD/475.

F. Adoption of the agenda

(Agenda item 6)

8. At its opening plenary meeting, the Conference adopted the provisional agenda for its thirteenth session, as contained in document TD/443.

9. Bearing in mind the importance of strengthening UNCTAD, ensuring effective management, and the need for member States to exercise effective oversight over the work of the organization, the Conference decided that (a) the Trade and Development Board would meet in special session six weeks after the official circulation of the document “Review of management and administration in the United Nations Conference on Trade and Development (UNCTAD)” (JIU/REP/2012/1) in all official languages of the United Nations, in order to address the report and its contents, and decide on ways for follow-up and effective implementation of the Board’s decisions; (b) the annual regular sessions of the Trade and Development Board would consider and evaluate the progress of the implementation of decisions on the report and take action, as appropriate; and (c) in that regard, the Trade and Development Board would report on progress to the next Conference.

10. The representative of Cuba expressed reservations with what he felt was an inconsistent position taken by some developed countries concerning the Conference’s consideration of the JIU report. Despite his reservations, he agreed with the adoption of the draft agenda as contained in document TD/443.

G. General debate

(Agenda item 7)

11. In the course of the general debate, statements were made by, or on behalf of, 94 member States, the observer for Palestine, two United Nations bodies and specialized agencies, and six intergovernmental organizations. Statements and archived videos of the general debate can be found at www.unctadxiii.org.

H. Other business

(Agenda item 9)

(a) Periodic review by the Conference of the lists of States contained in the annex to General Assembly resolution 1995 (XIX)

12. At its closing plenary meeting, on 26 April 2012, the Conference endorsed the lists of States contained in document TD/B/INF.222 (see annex VIII).

(b) Report of the Trade and Development Board to the Conference

13. At the same meeting, the Conference took note of the report of the Trade and Development Board to the Conference, contained in document TD/460.

(c) Financial implications of the actions of the Conference

14. At the 286th (closing) plenary meeting, on 26 April, Mr. Petko Draganov, Deputy Secretary-General of UNCTAD, informed the Conference that the activities resulting from adoption of the Doha Mandate would be met from resources approved by the General Assembly in the programme budget for the biennium 2012–2013.

I. Adoption of the report of the Conference to the General Assembly

(Agenda item 10)

15. Also at its closing plenary meeting, the Conference adopted its report to the General Assembly, on the understanding that it would be finalized to take into account the proceedings of the closing plenary meeting under the authority of the Rapporteur. The Doha Manar (TD/L.425) and the Doha Mandate (TD/L.427/Rev.1) are published as addenda and are considered integral parts of this report.

J. Expression of gratitude to the Government and people of the State of Qatar

16. At the closing plenary meeting, the Conference adopted by acclamation an expression of gratitude to the Government and people of the State of Qatar, as presented in document TD/476.
