969th plenary meeting

<u>Item 3</u> - <u>Interdependence and global economic issues from a trade and development perspective: New features of global interdependence</u>

Dr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made a general introduction. Mr. Heiner Flassbeck, Officer-in-Charge of the Division for Globalization and Development Strategies, made a detailed introductory statement with reference to the *Trade and Development Report*, 2005.

The general debate was opened.
