1007th and 1008th plenary meetings

Item 2 High-level segment: Globalization and inclusive development

Continuation of the interactive debate.

Representatives of the following States made statements: Mexico, India, Benin, Belarus, Pakistan and the Islamic Republic of Iran. The Secretary-General of UNCTAD made some concluding remarks.

Item 9 Preparatory process for the twelfth session of the Conference

(a) Establishment of the Preparatory Committee

The Board decided to establish an open-ended Preparatory Committee, to be chaired by the President of the Board.

(b) Approval of the provisional agenda for the Conference

The Board approved the draft provisional agenda for the Conference.

The Secretary-General of UNCTAD made a statement. Representatives of the following States took part in the discussion: Canada, Brazil, Portugal (on behalf of the European Union), United States of America, Honduras, Islamic Republic of Iran, Norway, Philippines, Switzerland, Bolivarian Republic of Venezuela, Russian Federation, Cuba, Ghana, Chad, Côte d'Ivoire and Brazil. The Acting Deputy Secretary-General of UNCTAD also participated in the discussion.

The Honourable Minister Joe Baidoe-Ansah, Minister of Trade, Industry, Private Sector Development and President's Special Initiatives of Ghana made a statement and presented a video on Ghana entitled "Ghana: an emerging business and conference destination".
