- (c) There are 200 NGOs in status with UNCTAD, 110 in the general category and 90 in the special category. There are 21 national NGOs included in the register (TD/B/NGO/LIST/9). The Board approved an application for observer status from the World Forum of Civil Society Networks (UBUNTU) (TD/B/55/R.1).
- (d) The Board approved the calendar of meetings for the remainder of 2008 and the provisional calendar for 2009.
