1025th plenary meeting

Item 7 Development strategies in a globalized world: Financial policies and productive investment related to trade and development

Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made an opening statement.

Mr. Detlef Kotte, Head, Macroeconomic and Development Policies Branch, made an introductory statement.

The secretariat made a presentation on capital flows, financial policies and investment.

Professor Gerald Epstein, Co-Director of the Political Economy Research Institute of the University of Massachusetts, made a presentation.

In the interactive debate that followed, representatives of the following member States took the floor: Zimbabwe (on behalf of the Group of 77); Argentina (on behalf of the Group of Latin American and Caribbean States); Indonesia (on behalf of the Asian Group); France (on behalf of the European Union); China; the Islamic Republic of Iran; Russian Federation; and Honduras.

Special event on Cape Verde

A special meeting was held on the "One United Nations" initiative to present the UNCTAD-led joint programme on graduation from the category of least developed countries and integration into the world economy.

A recorded statement of the Prime Minister of Cape Verde, H.E. Mr. José Maria Pereira Neves, was shown. The following panellists then made statements: Mr. Supachai Panitchpadki, Secretary-General of UNCTAD; Mr. Shishir Priyadarshi, Director of the Development Division of World Trade Organization; Ms. Petra Lantz De Barnardis, United Nations Resident Coordinator, Cape Verde; and Ms. Fatima Fialho, Minister of Economy, Growth and Competitiveness of Cape Verde.

This was followed by interventions from: the Food and Agriculture Organization; the International Trade Centre; the United Nations Industrial Development Organization; and the United Nations Development Programme (agencies of the Chief Executive Board Cluster on Trade and Productive Capacity participating in the Joint Programme). The representative of Angola took the floor.
