Sessional Committee I - First plenary meeting

Item 5 Contribution of UNCTAD to the implementation of the Programme of Action for the Least Developed Countries for the Decade 2011–2020: Third progress report

Sessional Committee I was opened by the Chair of the Committee, H.E. Mr. Thomas Fitschen (Germany). The Committee elected H.E. Mr. Eloi Laourou (Benin) as Vice-Chair-cum-Rapporteur.

Sessional Committee I began its consideration of agenda item 5 with a statement by Mr. Gyan Chandra Acharya, Under-Secretary-General and High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States (by recorded video message). This was followed by a statement by Mr. Mukhisa Kituyi, Secretary-General of UNCTAD. Mr. Taffere Tesfachew, Director, Division for Africa, Least Developed Countries and Special Programmes, introduced the report by the UNCTAD secretariat.

Statements were made by the following delegations: Chad, on behalf of the Group of 77 and China; Uruguay, on behalf of the Latin American and Caribbean Group; the Philippines, on behalf of the Asian Group; the United Republic of Tanzania, on behalf of the African Group; the European Union, on behalf of the European Union and its member States; the United States of America, on behalf of JUSSCANZ; Benin, on behalf of the least developed countries; South Africa; Ethiopia; China; Sierra Leone; Angola and the United Republic of Tanzania.

Mr. Taffere Tesfachew, Director, Division for Africa, Least Developed Countries and Special Programmes, made concluding remarks and replied to questions by delegations.

Sessional Committee I concluded its deliberation on agenda item 5.
